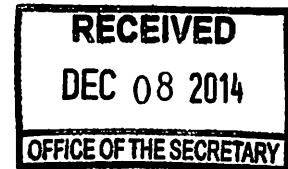


**DIVISION OF ENFORCEMENT'S MOTION FOR SUMMARY DISPOSITION  
AGAINST JOHN ALLAN RUSSELL**

## MOTION FOR SUMMARY DISPOSITION

Pursuant to Rule 250(a) of the Rules of Practice, the Division of Enforcement (“Division”) hereby moves for summary disposition of its allegations in the Order Instituting Proceedings (“OIP”), dated September 17, 2014, against respondent John Allan Russell (“Respondent”). In support of this Motion the Division states:

1. By order entered November 24, 2014, the hearing officer granted Respondent additional time to file an answer to the OIP. However, Respondent has effectively answered the OIP in his email dated November 23, 2014 wherein he stated: “The fact is I am not and was not guilty, there never was any criminal intent. I did not break the law I (sic) and should not have taken the deal although at the time there were some extenuating circumstances with that on the day of the plea I was under the influence of narcotic drugs that had been prescribed me at the jail.” The Division requests that the Court extend Respondent’s time to oppose this motion for summary disposition commensurate with Respondent’s time to Answer, but accept this filing by the Division.
2. The Division relies upon the Memorandum of Law in Support of its Motion for Summary Disposition Against Respondent as well as the Division’s Request for Official Notice in Support of its Motion.


