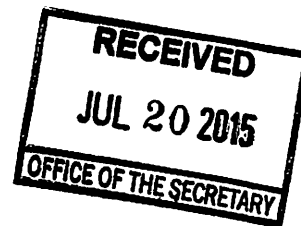

**Submission in Response to Brief in Support of Mr. Rowe's
Petition for Review of Initial Decision**

I, Peter N. Tamposi, neither a party nor counsel to any party in this case, file this submission in response to Mr. Rowe's Brief of May 14, 2015.

1. I do not represent Mr. Rowe in this matter, but am compelled to clarify my affidavit submitted by Mr. Rowe.

2. I was witness to the negotiations between Mr. Rowe and Messrs. Spill and Forcier regarding the Consent Order. I believe Spill and Forcier advocated for Mr. Rowe to agree to the Consent Order, but I do not believe they used any unethical tactics or unlawful means to that end.

3. In my opinion Mr. Rowe carefully considered the alternatives of a Consent Order, including but not limited to the hearing process at the Bureau of Securities Regulation, the potential penalty and the likely non-dischargeability of same in bankruptcy.

4. Although these factors informed Mr. Rowe's decision-making, I do not believe Mr. Forcier or Mr. Spill exerted any undue influence against Mr. Rowe.


