RESPONSE OF PAUL EDWARD "ED" LLOYD, JR., CPA, TO DIVISION OF ENFORCEMENT'S RESPONSE IN OPPOSITION TO RESPONDENT'S ANSWER AND MOTIONS

On November 7, 2014, the Division of Enforcement submitted a lengthy response opposing what it believed was a motion for summary disposition. Respondent has made no motion for summary disposition at this time, nor did he request leave of the hearing officer to make a motion for summary disposition. At such time as the respondent wishes to file a motion for summary disposition (and one is probable with respect to the jurisdictional and constitutional arguments), respondent will request leave, file the appropriate motion, the appropriate supporting materials, the appropriate briefs and supporting argument.

Consistent with the practice of virtually all federal district courts, respondent included in his answer defenses, which in a federal district court would also constitute Rule 12(b)(1) and 12 (b)(6) motions to dismiss. However, also consistent with the practice of most, if not all, federal district courts, no court would reach or rule upon such a motion until it was separately filed, in accordance with the federal rules and local rules, and properly briefed. The Commission's rules 250 and 154 appear, generally, to follow a similar practice. At present, respondent has identified significant issues which may result in the filing of a motion for summary disposition at a future time. At such time as respondent chooses to do so, he will file the appropriate motion, the appropriate supporting materials, and the appropriate argument. There is nothing before the

Commission to decide at this time. It would be inappropriate to deny a motion not yet made.
