

IT IS FURTHER STIPULATED that the Commission agrees not to argue at any time in any action or proceeding that acknowledging and accepting service or counsel's appearance on Ms. Bebo's behalf in this proceeding constitutes her consent to proceed in these proceedings or otherwise waives any challenges to the proceedings.

IT IS FURTHER STIPULATED that, pursuant to Rules 220 and 310 of the Commission's Rules of Practice, Ms. Bebo's answer to the OIP shall be due on December 26, 2014 and that failure to so answer could result in a default in the proceedings.






