DECLARATION OF NEIL J. WELCH, JR. TO ASSIST SECRETARY WITH RECORD OF SERVICE

NEIL J. WELCH, JR., pursuant to 28 U.S.C. § 1746, declares:

- 1. I am a Senior Investigations Counsel with the Division of Enforcement ("Division") of the Securities and Exchange Commission, and co-counsel for the Division in the above-captioned administrative proceeding. through postal channels. Canada does not object to such service. Randolph v. Hendry,
50 F. Supp.2d 572, 578 (S.D.W.Va. 1999).
