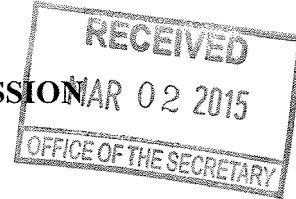

**DECLARATION OF DAVID S. FRYE
TO ASSIST SECRETARY WITH RECORD OF SERVICE**

DAVID S. FRYE, pursuant to 28 U.S.C. § 1746, declares:

1. I am a Senior Counsel with the Division of Enforcement (“Division”) of the Securities and Exchange Commission, and co-counsel for the Division in the above-captioned administrative proceeding. I am submitting this Declaration to assist the Secretary in maintaining a record of service on the respondents in the above-captioned proceedings pursuant to Rule 141(a)(3).

2. The Office of the Secretary provided me with the U.S. Priority Mail Express tracking numbers for the copies of the Order Instituting Proceedings (“OIP”) that were mailed by the Secretary to the respondents these proceedings. I input each of the tracking numbers into the U.S. Postal Service’s (“USPS’s”) package tracking system on its Internet website located at www.usps.com, and printed out the tracking confirmations in order to obtain confirmation of the delivery or attempted delivery of the OIP on each respondent. A true copy of the tracking confirmations for all of the respondents for whom express mail service was attempted is attached as Exhibit 1, hereto. Rule

141(a)(2)(ii) provides that service on a corporation or entity may be obtained by confirmation of attempted delivery on the most recent address shown on the entity's most recent filing with the Commission.

3. The Secretary mailed the OIP to respondent Energiz Renewable, Inc. CIK 859313 ("ERIP") via Priority Mail Express, Tracking No. [REDACTED]0US, to the address shown on its most recent EDGAR filing at [REDACTED]. This address is taken from ERIP's last filing with the Commission, which was a Form 8-K filed with the Commission on August 29, 2013. The USPS tracking system confirms that delivery was attempted on February 27, 2015, but the package was undeliverable as addressed. *See* Exhibit 1 at 1.

4. The Secretary mailed the OIP to respondent Iron Eagle Group, Inc. CIK 1043825 ("IEAG") via Priority Mail Express, Tracking No. [REDACTED] to the address shown on its most recent EDGAR filing at [REDACTED]. This address is taken from IEAG's last filing with the Commission, which was a Form 12b-25 filed with the Commission on November 15, 2013. The USPS tracking system confirms that the package was delivered on February 27, 2015. *See* Exhibit 1 at 2.


5. The Secretary mailed the OIP to respondent MedClean Technologies, Inc. CIK 40528 ("MCLN") via Priority Mail Express, Tracking No. [REDACTED] to the address shown on its most recent EDGAR filing at [REDACTED]. This address is taken from MCLN's last filing with the Commission, which was a Form 8-K filed with the Commission on September 10, 2013. The USPS tracking system confirms that delivery was attempted on February 27, 2015,

but the package was undeliverable as addressed and the forwarding address had expired.
