DIVISION'S STATUS REPORT REGARDING RESPONDENT'S OFFER OF SETTLEMENT AND MOTION TO CONTINUE THE STAY

Pursuant to the Law Judge's August 24, 2015 Order Granting Motion to Stay based on Respondent Albert J. Scipione's submission of a signed Offer of Settlement, the Division of Enforcements files this Status Report and Motion to Continue the Stay.

The Stay in these proceedings was contingent on the Division's submission of Mr. Scipione's Offer to the Commission by September 16, 2015. The Division hereby informs the Law Judge that after receiving Mr. Scipione's signed Offer of Settlement and submitting it for approval by the Commission, the Division became aware that the original Offer did not contain all the language necessary for the Commission to accept his Offer of Settlement. The Division has sent Mr. Scipione, who remains incarcerated, a letter with an amended Offer of Settlement (that contains all the necessary language), and requested that he execute and return the amended Offer of Settlement to the Division by no later than September 23, 2015.

Accordingly, we request that the Law Judge continue the stay and allow the Division until October 7, 2015 to submit Mr. Scipione's amended Offer of Settlement to the Commission. The Division believes that good cause exists for a continuance of the stay

and a 21 day extension of the deadline to submit Mr. Scipione's amended Offer of Settlement to the Commission. Moreover, the Division makes this request in good faith and not for purposes of delay.

In sum, a 21 day extension should allow enough time for Mr. Scipione to execute the amended Offer of Settlement (that includes all the necessary language), return it to the Division, and for the Division to submit it to the Commission for approval.
