Dear Mr. Bliss:

I write on behalf of Lynn Tilton, Patriarch Partners, LLC, Patriarch Partners VIII, LLC, Patriarch Partners XIV, LLC, and Patriarch Partners XV, LLC (collectively, "Respondents") in connection with the above-referenced matter regarding handwritten notes previously produced by the Division of Enforcement (the "Division") and recent meetings and correspondence between the Division and witnesses conducted in connection with this proceeding.

On May 27, 2015, the Division produced a number of handwritten notes taken by Division staff in relation to communications and meetings with various witnesses, bearing Bates numbers SECNOTES000001 – SECNOTES000764. Respondents request more detailed information concerning 17 sets of these notes (hereinafter, the "Requested Notes," enclosed as Appendix A). In particular, for each of the Requested Notes, please provide: 1) the author(s)'s name; 2) the identification of the person(s) whose statements the notes reflect; 3) the date(s) upon which the notes were taken; 4) the date(s) of any phone calls or meetings with any person reflected therein; and 5) any audio recordings of the interview or any audio recordings received by the Division from the individual(s) interviewed.

On a separate note, within the past two weeks, the Division has been in contact with a number of witnesses in connection with the above-referenced matter. (A list of known meetings and correspondence conducted between the Division and witnesses may be found in Appendix B, enclosed.) Respondents request the Division produce any notes concerning

Mr. Mastro – we have reviewed the specific documents you identified in your email. As you know, on May 27, 2015, the Division produced redacted copies of confidential internal witness interview notes to Respondents' prior counsel. While we did not expect Respondents to use these documents beyond the Commission's administrative proceeding when they were produced, we agree that there was not a protective order entered by the Administrative Law Judge and have not identified an explicit agreement between the Division and prior counsel for Respondents regarding use of these documents.

We have reviewed the documents you have identified and do not believe there sufficient reason to require sealing from the public record. Therefore, the Division does not object to Respondents filing the specific documents publicly on the District Court's electronic docket. We would ask, however, that if you intend to make use of any other documents produced by the Division in the administrative proceeding, including the documents produced on May 27, 2015 (SECNOTES000001-000764), that you notify the Division of the intended use so that we can determine whether or not to seek a protective order regarding their use.

By not objecting to Respondents' public filing of these documents, the Division is not waiving any applicable privilege or protection.

Finally, we decline to provide additional information regarding the author(s) of the documents. You do not cite – and we are not aware of – any legal basis for this request, nor do we see how the information is relevant.

Counsel:

We represent Patriarch Partners XV, LLC and Octaluna LLC (collectively, "Plaintiffs") in a pending civil action captioned *Patriarch Partners XV*, *LLC v. U.S. Bank National Ass'n*, No. 1:16-cv-07128-JSR (S.D.N.Y.) (the "PPXV Case"). As you know, we also represent the Respondents here, including Patriarch Partners XV, LLC, in the pending administrative and cease-and-desist proceedings before the Commission captioned *In re Lynn Tilton*, File No. 3-16462 (the "Administrative Proceeding").

I write regarding certain documents previously produced by the Commission's Division of Enforcement (the "Division") in connection with the Administrative Proceeding, which Division staff unilaterally described as "confidential" at the time of production, even though, as we understand it, no protective order was ever entered and no agreement ever reached between the parties permitting the Division to make any such designation. The documents at issue—which are Bates numbered SECNOTES000495-96, SECNOTES000656-70, SECNOTES000715-18, SECNOTES000721-25, and SECNOTES000726-28 (collectively, the "Documents")—are copies of handwritten interview notes prepared by one or more Division attorneys in connection with the investigation that gave rise to the Administrative Proceeding. In the PPXV Case, Plaintiffs recently submitted copies of those Documents to U.S. District Judge Jed Rakoff of the Southern District of New York, to whom the PPXV Case has been assigned, in connection with their application seeking a preliminary injunction against the Defendants in that case.

Division counsel described these Documents as "confidential" in a production cover letter dated May 27, 2015, and stamped the documents with a confidentiality legend. Again, it is our understanding, however, that the Documents are not subject to confidential treatment, given that the Administrative Law Judge presiding over the Administrative Proceeding has not entered a protective order providing for confidential treatment of the Documents and no confidentiality agreement exists between the Division and the Respondents in the Administrative Proceeding permitting the Division to make any such designation. Thus, Plaintiffs believe that the Documents should be filed publicly on the District Court's electronic docket for the PPXV Case. Nevertheless, given the Division's reference to the "confidential" nature of the Documents, Plaintiffs submitted the Documents directly to Judge Rakoff to request and await guidance from him on publicly filing them.

We therefore write to request the Division's position regarding whether the Documents may be publicly filed. We intend to contact Judge Rakoff's chambers later this morning at 11AM NY time to seek permission, in accordance with Judge Rakoff's Individual Rules of Practice, to submit a letter requesting a ruling that the Documents should be filed publicly, but we wanted to request the Division's position in advance of doing so.

Please let us know as soon as possible the Division's position regarding these Documents. And also please confirm as soon as possible who within the Division authored each of these Documents, which is information to which we are entitled. Given the time sensitivity here, we respectfully request the Division's response to these requests by today at 11AM NY time.
