THE DIVISION OF ENFORCEMENT'S MOTION FOR SUMMARY DISPOSITION

The Division of Enforcement respectfully submits this Motion for Summary Disposition against Respondent Paul D. Crawford ("Crawford") pursuant to Rule 250 of the Rules of Practice. This administrative proceeding arises from a related injunctive action, <u>SEC v. Collyard, et al.</u>, No. 11-CV-3656 (D. Minn.), in which the District Court found that Crawford violated Section 15(a) of the Securities Exchange Act of 1934 by acting as an unregistered broker-dealer. The District Court permanently enjoined Crawford from future violations of this section. The court made specific findings of fact that collectively establish that the public interest would best be served by barring Respondent Crawford from associating with any broker, dealer, investment advisor, municipal securities dealer, or transfer agent.
