Update on Status of *United States v. Sears*, No. 16-cr-301 (D. Colo.)


On October 4, 2018, Administrative Law Judge James E. Grimes issued an Order on Procedures noting that hearings in these proceedings cannot be convened until entry of a final judgment in *United States v. William Sears and Scott Matthew Dittman*, No. 16-cr-301-WJM (D. Colo.), and directed the Division of Enforcement to file a status update every six months or upon entry of a final judgment in *Sears*.

The Court in *United States v. Sears* had postponed sentencing and entry of final judgment against William Sears and Scott Dittman pending a criminal trial in another related matter, *United States v. Guy M. Jean-Pierre, a/k/a Marcello Moninguez de Guerra*, 17-cr-00008-WJM(s) (D. Colo.). On January 30, 2019, the jury in that matter found

Mr. Jean-Pierre guilty of facilitating a \$12 million stock fraud scheme based on shares of Fusion Pharm. The sentencing hearing for Messrs. Sears and Ditman is now set for July 11, 2019.


