STIPULATION OF DIVISION OF ENFORCEMENT

AND RESPONDENT ALEXANDER KON

The Division of Enforcement and Respondent Alexander Kon hereby stipulate and agree to the statements below. Nothing in this stipulation shall preclude either party from introducing evidence in addition to the statements herein, provided that evidence does not directly contradict a matter stipulated to.

- 1. Alexander Kon resides in Overland Park, Kansas.
- During the relevant time period, Alexander Kon operated 007Stockchat LLC, which also operated as Stockchat LLC.
- 3. Cannabusiness Group Inc, is a now defunct Nevada corporation that had its principal executive office in Vacaville, California.
- Michael Cummings was the CEO and principal of Cannabusiness during the time of the relevant events. Michael Cummings died in May, 2016.

5. After various e-mail exchanges and a phone call between Michael Cummings and

Alexander Kon, Kon agreed that he would run a marketing campaign for Cannabusiness

for \$25,000 on or about April 14, 2014.

6. Kon agreed the marketing campaign would be operated through four websites: 007

Stockchat.com; awesomestocktips.com; otcfire.com and pennystockspy.com. In addition,

they agreed that Kon would email the publications to addresses he had accumulated on an

email distribution list.

7. Kon received \$25,000 to organize the promotional campaign through a wire transfer from

Freebird Capital.

8. Casey Cummings settled with the SEC for various charges related to the scheme on

November 14, 2016.

9. The disclosure on the four websites and e-mails noted that Kon received \$25,000 from

"third party... Casey Cummings."

Division Exhibits and all exhibits on Respondent's Exhibit List are admissible without

the need for testimony by a records custodian or further authentication. All objections to

these exhibits are waived except objections based on relevance. Either party may use any

documents on the other party's exhibit list to the same extent as if the document had been on

its own list.
