FINRA'S REPLY IN SUPPORT OF ITS MOTION TO DISMISS ZIPPER'S APPLICATION FOR REVIEW AND TO STAY BRIEFING SCHEDULE

On May 31, 2017, ¹ Zipper filed a brief with the Commission opposing FINRA's motion to dismiss and restating his belief that FINRA is engaged in a cover-up, expanding the circle of alleged malfeasance to FINRA's Office of General Counsel. He maintains that FINRA is lying and hiding conversations that Zipper allegedly had with FINRA's Department of Enforcement personnel the day after he executed his Letter of Acceptance, Waiver & Consent ("AWC").

To support his contention that he had these conversations, and his "smoking gun" that FINRA is engaged in a conspiracy against him, Zipper points to a letter that he wrote to FINRA's Ombudsman on May 5, 2017 and sent to the Commission on May 8, 2017 ("Ombudsman Letter"). (RP 205.)² In that letter, Zipper recounts conversations that he

In his opposition, Zipper refers to the Ombudsman Letter as the "May 8" letter to the Commission. However, in his correspondence with FINRA's Office of General Counsel, he refers to it as the "May 5" letter or "exhibit D." <u>See</u> e-mail chain from Zipper to Michelle Parker and Colleen Durbin, attached hereto as <u>Exhibit A</u>.
