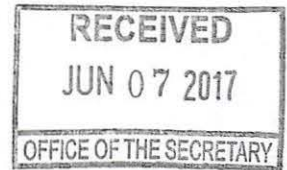

PETITION FOR TERMINATION OF SUSPENSION OF TRADING OF SECURITIES

SUNSHINE CAPITAL, INC., (hereinafter "SUNSHINE" or the "COMPANY") and JIMMY WAYNE ANDERSON (hereinafter "ANDERSON") in his capacity as an officer of SUNSHINE, hereby file this Petition for Termination of Suspension of Trading of Securities (hereinafter "Petition"), pursuant to the Securities and Exchange Commission (hereinafter the "SEC") Rules of Practice Section 550.


In support thereof, SUNSHINE and ANDERSON allege as follows:

1. SUNSHINE, a Nevada corporation, is a holding company currently concentrating in the Crypto currency space.
2. ANDERSON is an officer of SUNSHINE and serves as the Director of Regulatory Affairs.
3. On April 11, 2017, the SEC pursuant to Section 12(k)(1)(A), of the Securities and Exchange Act, as amended (hereinafter the "Exchange Act"), suspended the trading of SUNSHINE'S securities (hereinafter the "Suspension Order").

WHEREFORE, the Petitioners respectfully request the Commission enters an order terminating the suspension of trading in the securities of SUNSHINE CAPITAL, INC. since the Company's future operational plans are void of any Crypto currency business model.


