NOTICE OF APPEAL TO THE U.S. SECURITIES AND EXCHANGE COMMISSION

Comes now David K. Mallett hereinafter referred to as "Respondent", by his attorney,

and for his Notice of Appeal states:

1. On May 8, 2017, Respondent received notice from Financial Industry Regulatory

Authority (FINRA) that he was suspended from Association as of May 8, 2017.

2. Respondent disagrees with FINRA'S decision and hereby appeals that decision to the

U.S. Securities and Exchange Commission.

3. For cause, Respondent states:

a. He did not fail to report the arrest incident described in paragraph 1 of FINRA'S letter dated September 7, 2016. While not reported on a specific form, on July 18, 2016, the arrest was published in the lical newspaper and the undersigned responded to a telephonic request from Wunderlich's attorney, Jim Ritt and provided him with an oral summary of the events and sent copies of all documents in his possession related to the arrest and subsequent charges. A copy of that e-mail is attached hereto as exhibit 1.

b. On September 15, 2015, he was not aware that the lien should be reported to his employer. Less that three months later, he made his employer aware of the filing of the lien.

c. On or about August 21, 2016, Respondent moved from his former marital home at 4801 Brandywine Cove, North Little Rock, AR 72120. He filed forwarding orders with the United States Postal Service, but did not receive any of the letters from FINRA.

d. Although working for Wunderlich, he did not receive any correspondence from his employer.

e. FINRA failed to exercise due caution/diligence when trying to serve Respondent with Notices.

f. Respondent suffered from a medical disability during a majority of the time that the events described in the FINRA letter occurred that made it difficult for him to make rational decisions.
