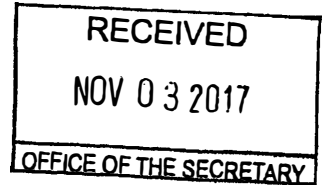

DECLARATION OF NEIL J. WELCH, JR. IN SUPPORT OF
DIVISION OF ENFORCEMENT'S MOTION FOR SUMMARY DISPOSITION

NEIL J. WELCH, JR., pursuant to 28 U.S.C. § 1746, declares:

1. I am a Senior Investigations Counsel with the Division of Enforcement ("Division") of the Securities and Exchange Commission ("Commission"), and co-counsel for the Division in the above-captioned administrative proceeding. I submit this Declaration in support of the Division's Motion for Summary Disposition against respondent Can-Cal Resources Ltd. ("Can-Cal").
2. Attached hereto as Exhibit 1 is a true copy of a list of all of Can-Cal's filings on EDGAR as of November 3, 2017.
3. Attached hereto as Exhibit 2 is a true copy of a delinquency letter dated November 20, 2015 sent by the Division of Corporation Finance to Can-Cal, and a true copy of the U.S. Postal Service tracking data showing that delivery was attempted on December 10, 2015.
4. Attached hereto as Exhibit 3 is a true copy of an Order of Suspension of Trading dated June 8, 2017 issued by the Commission against Can-Cal.

5. Attached hereto as Exhibit 4 is a true copy of an email from Can-Cal's counsel to Division counsel dated October 3, 2017, identifying Can-Cal's auditor as Thomas M. "Mickey" O'Neal, CPA, with Thayer O'Neal Company, LLC in Houston, Texas.

6. Attached hereto as Exhibit 5 is a true copy of a printout from the OTC Markets website, www.OTCMarkets.com for Can-Cal's stock symbol CCRE on November 3, 2017.

7. Attached hereto as Exhibit 6 are true copies of Can-Cal's Forms 8-K filed on EDGAR on June 13, 2016, September 21, 2016, and July 24, 2017.


8. Attached hereto as Exhibit 7 are true copies of a Custodian Declaration from Can-Cal's stock transfer agent, Pacific Stock Transfer Co., and pages 18, 34, 45 of Can-Cal's list of shareholders showing stock certificates issued as of October 3, 2017.

9. On October 4, 2017, I spoke to Thomas M. "Mickey" O'Neal by telephone, and Mr. O'Neal stated that while there were recent discussions with Can-Cal about doing new audit work for the respondent, his firm had not been engaged to do new audits of Can-Cal. Mr. O'Neal said his firm was still owed \$12,500 for past audit work for Can-Cal, and that any new audit work would require payment of the outstanding bill of \$12,500, an engagement letter, and a \$5,000 retainer. On October 30, 2017, I telephoned Mr. O'Neal again to get an update on the status of the audit of Can-Cal, and

he told me that Can-Cal had sent him a wire of approximately \$10,000 (Canadian) the week of October 23, 2017, but he would still need approximately another \$10,000 to have his past bill paid off and provide him with the required retainer for the new work.

I declare under penalty of perjury that the foregoing is true and correct.
