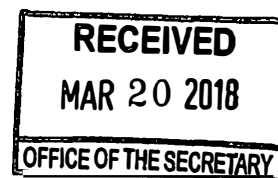

**DIVISION OF ENFORCEMENT'S REPLY IN SUPPORT OF AN ORDER OF  
SUMMARY DISPOSITION AGAINST RESPONDENT  
GLOBAL DIGITAL SOLUTIONS, INC.**

As evidenced by GDSI's Opposition to the Division's Motion, there is no dispute that GDSI has not filed its required Form 10-K Annual Reports beyond its 2014 Form 10-K, and has not filed its required Form 10-Q Quarterly Reports beyond its third-quarter 2015 Form 10-Q Reports. See Opposition at 3 and attached Affidavit of William Delgado, ¶15. There is thus absolutely no dispute that GDSI has failed to comply with Section 13(a) of the Exchange Act and Rules 13a-1 and 13a-13.

Notwithstanding this concession, in an attempt to mitigate or avoid punishment for its flagrant and admitted violations, Respondent's Opposition attempts to excuse its non-compliance and urges the Law Judge to take its word that it will do better in the future. However, the law is clear that both attempts are unavailing and do not help GDSI escape the inevitable conclusion that its registration for each class of registered securities must be revoked under the non-exclusive *Gateway Int'l Holdings Inc.* test.<sup>1</sup> Nothing that GDSI has set forth is "strongly

compelling” that a sanction short of revocation would be appropriate. *Impax Laboratoires Inc.*, Exchange Act. Rel. No. 57864, 2008 WL 2167956, \*8 (May 23, 2008).

GDSI’s violation is serious. It has been several years since investors have had current financial information about GDSI. The last filing pertaining to a Form 10-K or Form 10-Q was on March 30, 2016, where GDSI filed a Form 12b-25 Notification of Late Filing. (Exhibit A). In it, GDSI stated, in sum, that it was unable to file the Form 10-K because its independent auditors had not been able to complete the audit of its financial statements. GDSI then stated it hoped to be able to file the Form 10-K by April 14, 2016. This, of course, did not happen. “Investors were [then] left to guess why [GDSI] could not file its quarterly reports...and were left to guess about its fortunes.” *Solar Acquisition Corp.*, Initial Decision Rel. No. 913, 2015 WL 6777072, \*4 (Nov. 6, 2015) (citing *Absolute Potential Inc.*, Exchange Act Rel. No. 71866, 2014 WL 1338256, at \*4 (Apr. 4, 2014) (finding “serious” violations where company failed to timely file four period reports across two years, despite company’s filing of past-due reports)); *China Biotics Inc.*, Exchange Act Rel. No. 70800, 2013 WL 5883342 at \*9 (Nov. 4, 2013).

Of course, GDSI’s delinquencies were recurrent and not isolated, as it failed to file any required report since November 6, 2015. Also, it has a high degree of culpability since it knew about the mandatory requirement to file a Form 12b-25 when it was unable to file a Form 10-Q or 10-K, and yet only filed one in 2016. (Exhibit B). See *Solar Acquisition*, 2015 WL 6777072 at \*5 (failure to file subsequent Forms 12b-25 reflect “lack of concern for meeting [] reporting obligations and for the investing public”). Further, even though counsel has averred that he has been retained to ensure that delinquent filings are completed and filed and that future filings are timely completed and filed as required, this is not evidence. See *Wood ex Rel. United States v. Am. Ins. In Tawain*, 286 F.3d 526, 534 (D.C. Cir. 2002); *Bilogic, Inc., et al.*, Initial Decision Rel.

No. 322, 2006 WL 3253634 at \*4 (Nov. 9, 2006) (granting Division's motion for summary disposition: "As a general matter, a respondent cannot defeat the Division's motion...by using its attorney to make vague, generalized representations about its beliefs and aspirations").

While Delgado avers that GDSI intends to comply with its past obligations and future obligations on an attached schedule, it has not done so for 2 ½ years. GDSI's litany of excuses as averred to by Delgado do not offer any respite. *See e.g. Absolute Potential*, 2014 WL 1338256 at \*4 (lengthy delinquencies resulting from company disarray not a cognizable defense).

In light of its previous broken promise of future compliance, GDSI's credibility is dubious at best. Such promises of future compliance routinely fall far short of the "strongly compelling" showing required to avoid revocation. *Id.* at \*4; *Impax*, 2008 WL 2167956 at \*8.

Furthermore, even if GDSI were to become fully current, consistent with the aspirational schedule attached to Delgado's Declaration, little – if any – credit is given to registrants that ignore their filing requirements and then hurriedly become current during a Commission proceeding. As Judge Foelak noted in revoking the registration of a such a registrant, "dismissal or a lesser sanction [than revocation] would reward issuers who fail to file required periodic reports over an extended period and become current only after enforcement proceedings are brought against them, essentially providing an automatic lengthy postponement of the prescribed filing dates for such issuers to the detriment of the public interest and investors." *Law Enforcement Associates Corp.*, Initial Decision Rel. No. 487, 2013 WL 2039311 at \*4 (May 15, 2013); *see also, Nature's Sunshine Products, Inc.*, Exchange Act Rel. No. 59268, 2009 WL 137145 at \*8 (Jan. 21, 2009) (same); *Medis Technologies Ltd.*, Initial Decision Rel. No. 488,

2013 WL 2246028 at \*5 (May 22, 2013) (issuer's registration revoked where it was less than two year's delinquent and brought itself current after institution).

In sum, a full analysis of the *Gateway* factors establishes that revocation is the appropriate remedy for GDSI's numerous and repeated violations. GDSI's recurrent failures to file its periodic reports have not been outweighed by "a strongly compelling showing with respect to the other factors" which "would justify a lesser sanction than revocation." *Impax*, 2008 WL 2167956 at \*8. Making an exception in GDSI's case would weaken the deterrent effect of Section 12(j) of the Exchange Act on delinquent filers.

In any case, revocation will not be overly harmful to whatever business operations, finances, or shareholders GDSI may now have. Revocation will not cause GDSI to cease being the kind of company it was before its securities registration was revoked. *See Eagletech Communications, Inc.*, Exchange Act Rel. No. 54095, 2006 WL 1835958 at \*4 (July 5, 2006) (revocation would lessen, but not eliminate, shareholders' ability to transfer their securities). Moreover, a revocation order would not prevent GDSI from filing a new Exchange Act Section 12 registration statement if it desires to again become a publicly-traded company. Therefore, the Division respectfully requests the Administrative Law Judge grant the Division's Motion for Summary Disposition and revoke the registration of GDSI's securities registered under Exchange Act Section 12.

The decrease in the net loss is primarily due to lower selling, general and administrative expenses in 2015, including less non-cash compensation charges and less acquisition costs that were incurred in connection with an acquisition in 2014. The decrease in selling, general and administrative expenses in 2015 is partially offset by an increase in other income/expense in 2015 as compared to 2014. The Company's estimated net loss for the year ended December 31, 2015 as presented herein is preliminary and subject to change and should not be relied on.

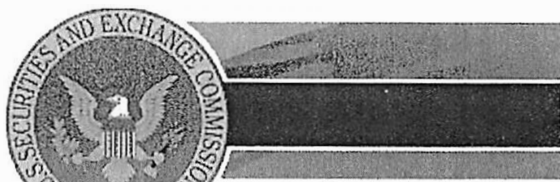

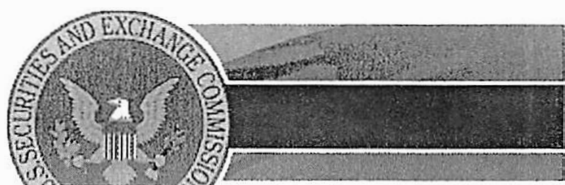
