On May 17, 2018, pursuant to Rule 420 of the Commission's Rules of Practice and Section 19(d)(2) of the Securities Exchange Act of 1934, 15 U.S.C. 78s(d)(1) (the "Exchange Act"), Windsor Street Capital, L.P. (the "Firm" or "Windsor") filed an application for review of a FINRA National Adjudicatory Council Decision of May 14, 2018 (the "NAC Decision") In the Matter of the Continued Membership of Windsor Street Capital, L.P. denying Windsor's Membership Continuance Application ("MC-400A" or "the Application") and terminating its FINRA membership.

At the same time, Windsor filed Windsor an Expedited Motion for a Stay of the FINRA NAC Decision, which was denied by the Commission in Release No. 83340/May 29, 2018. As a result, Windsor's FINRA membership was terminated by FINRA on May 29, 2018 and Windsor has ceased its broker/dealer business.

In view of the foregoing, Windsor Street Capital, L.P. hereby withdraws its application to the Commission for Review of the NAC Decision.
