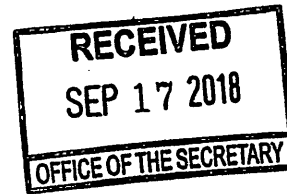

2 corporation, on or about September 10, 2018, Respondent filed the necessary paperwork with the  
3 Nevada Secretary of State to address the cause of the revocation, which was due to Respondent's agent  
4 for service of process no longer doing business in the State of Nevada.


