**DIVISION OF ENFORCEMENT'S MOTION FOR**  
**DEFAULT AND BRIEF IN SUPPORT**

The Division of Enforcement ("Division"), by counsel, pursuant to Commission Rules of Practice Rules 154(a) and 155(a)(2) respectfully moves the Securities and Exchange Commission ("Commission") for an order entering a default against American Smooth Wave Ventures, Inc. (CIK No. 1441649) ("American Smooth Wave" or "Respondent") in this proceeding and ordering the revocation of the registration of each class of Respondent's securities registered pursuant to Section 12 of the Securities Exchange Act of 1934 ("Exchange Act").

**Argument**

On July 24, 2019, the Commission issued an Order Instituting Proceedings ("OIP") against Respondent which has securities registered with the Commission under Section 12(g) of the Exchange Act. The OIP alleges the Respondent is delinquent in filing its mandated periodic reports. Because Respondent failed to answer or otherwise respond to the OIP, the Division now seeks entry of an order finding respondent American Smooth Wave to be in default in this proceeding.

Commission Rule of Practice 220(b) states that where an answer is required to be filed by rule or order, the respondent “shall do so within 20 days after service upon the respondent of the order instituting proceedings” unless a different period is provided by rule or order. Here, the OIP requires “an Answer [to be filed] to the allegations contained in this Order within ten (10) days after service of this Order.” OIP at IV. Commission Rule of Practice 160(a) provides that Saturdays, Sundays and Federal legal holidays are to be counted as part of the 10 day period, and Commission Rule of Practice 160(b) extends that time by three days if service is made by mail.

The Declaration of Gina Joyce to Assist Secretary with Record of Service (attached hereto as Exhibit A) establishes that American Smooth Wave is headquartered in China, but is incorporated in Iowa, and that American Smooth Wave’s registered agent for service of process is Corporation Service Company. On August 1, 2019, American Smooth Wave, through its registered agent, was served, by Express Mail delivery, with the OIP, along with a letter from the Commission’s Secretary, and a letter from the Division offering discovery pursuant to Rule of Practice 230. American Smooth Wave’s answer to the OIP was due by Wednesday, August 14, 2019. However, American Smooth Wave has not filed an answer or made any other response to the OIP in this proceeding.

The Respondent at issue is delinquent in its filings with the Commission and has been delinquent for over two years. In addition, the Respondent’s failure to answer supports revocation of the registration of each class of Respondent’s securities. Accordingly, the Division moves for an order, pursuant to Rule 155(a)(2), finding this Respondent to be in default in this proceeding and ordering that the registration of each class of its securities registered pursuant to Exchange Act Section 12 be revoked.


**Conclusion**

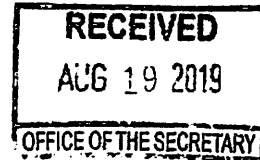

**DECLARATION OF GINA JOYCE**  
**TO ASSIST SECRETARY WITH RECORD OF SERVICE**

GINA JOYCE, pursuant to 28 U.S.C. § 1746, declares:

1. I am Senior Counsel with the Division of Enforcement (“Division”) of the Securities and Exchange Commission, and co-counsel for the Division in the above-captioned administrative proceeding. I am submitting this Declaration to assist the Secretary in maintaining a record of service of the Order Instituting Proceedings (“OIP”) on the respondent, in the captioned proceeding pursuant to Rule of Practice 141(a)(3).

2. As shown in Exhibit 1, the Respondent in this proceeding, American Smooth Wave Ventures, Inc. (“American Smooth”), is located in the People’s Republic of China (“China”). Though China is a signatory to the Hague Convention on the Service Abroad of Judicial and Extrajudicial Documents (“Hague Convention”), 20 U.S.T. 361, T.I.A.S. 6638, 658 U.N.T.A. 163 (1964), it objects to service by mail under Article 10(a). Thus, in order to perfect service on the Respondent in China, the Division would be required to have the document translated into Chinese and request the assistance of the Central Authority of China, a process which could delay service by

more than a year. Therefore, the Division chose to first attempt service by means other than through the Hague Convention.


3. Respondent American Smooth's last EDGAR filing was a Form 10-Q/A filed on August 25, 2011, which gave an address in Jinjiang City, Fujian Province, China. A true copy of a printout of the first page of Form 10-Q/A filed on August 25, 2011 is attached hereto as Exhibit 1. However, American Smooth is an Iowa corporation. A search of the website of the Iowa Secretary of State revealed that the name and address of American Smooth's registered agent is Corporation Service Company, Registered Agent, 505 5th Avenue, Suite 729, Des Moines, IA 50309. A true copy of a printout of the summary page and the filings page of American Smooth's corporate status pages from the website of the Iowa Secretary of State are attached hereto as Exhibit 2. Therefore, the Division provided the registered agent's address to the Office of the Secretary and requested that the Secretary attempt service on American Smooth's Iowa registered agent via U.S. Priority Mail Express. The Secretary mailed the OIP to American Smooth's registered agent at the address referenced above via U.S. Priority Mail Express, Tracking No. EF 200199689 US. My search of the USPS tracking system, at [www.usps.com](http://www.usps.com), confirmed that the package was delivered on August 1, 2019. A true copy of the tracking confirmation is attached hereto as Exhibit 3.

4. As page 2 of Exhibit 2 shows, American Smooth has an administratively dissolved status with the State of Iowa. Iowa Code §490.1421(4) states: "The administrative dissolution of a corporation does not terminate the authority of its

registered agent.” In an unpublished opinion, the Court of Appeals of Iowa stated that:  
“A corporation administratively dissolved continues its corporate existence ...” Minger  
Const., Inc. v. Clark Farms, Ltd., 873 N.W.2d 301 (Iowa Ct. App. 2015).

I declare under penalty of perjury that the foregoing is true and correct.


