**CORRECTED DECLARATION OF
LESLIE KAZON TO ASSIST
SECRETARY WITH RECORD OF
SERVICE AND IN SUPPORT OF
DIVISION'S MOTION FOR
DEFAULT**

I, LESLIE KAZON, pursuant to 28 U.S.C. § 1746, declare:

1. I am an attorney, a senior advisor with the Microcap Fraud Task Force in the Division of Enforcement (“Division”) of the Securities and Exchange Commission, and counsel for the Division in the above-captioned administrative proceeding. I submit this Declaration to assist the Office of the Secretary (“Secretary”) in maintaining a record of service on the Respondents in the above-captioned proceedings pursuant to Commission Rule of Practice 141(a)(3) and in support of the Division’s Motion for Default.

2. The Secretary provided me with the U.S. Postal Service’s (“USPS’s”) Express Mail tracking numbers for the copies of the Order Instituting Proceedings (“OIP”) that the Secretary mailed to the Respondents in these proceedings. True copies of the mailing labels for each Respondent showing the tracking numbers are attached hereto as Exhibit 1. Staff under my supervision input each of the tracking numbers into USPS’s package tracking system on its

Internet website located at www.usps.com and printed out the tracking confirmations to obtain confirmation of the delivery or attempted delivery of the OIP on each Respondent. True copies of the tracking confirmations for each Respondent are attached as Exhibits 2 through 4.

3. The Secretary mailed the OIP to respondent A La Carte Charts Corp. (“A La Carte”) (CIK No. 1672900) via Express Mail, Tracking No. EJ047974185US, to 42211 North 42nd Drive, A105, Phoenix, AZ 85086. This address is listed as A La Carte’s address on its most recent EDGAR filing with the Commission: A La Carte’s Form 8-K filed on February 16, 2018. The USPS tracking system confirms that delivery was attempted on August 30, 2019, but the package was undeliverable as addressed. *See* Exhibit 2.

4. The Secretary mailed the OIP to respondent Iron Sands Corp. (“Iron Sands”) (CIK No. 1527727) via Express Mail, Tracking No. EJ047974163US, to 1999 Broadway, Suite 3700, Denver, CO 80202. This address is listed as Iron Sands’ address on its most recent EDGAR filing with the Commission: Iron Sands’ Form 8-K filed on December 20, 2017. The USPS tracking system shows that on August 30, 2019, USPS found that the address did not exist and the package was thus undeliverable as addressed. *See* Exhibit 3.

5. The Secretary mailed the OIP to respondent TOPAW, Inc. (“TOPAW”) (CIK No. 1317456) via Express Mail, Tracking No. EJ047974177US, to TOPAW, c/o Joel A. Lucas, 3211 Burnbrook Lane, Baltimore, MD 21207. This address is listed as TOPAW’s address on its most recent EDGAR filing with the Commission: TOPAW’s Form 10SB-12G filed on December 5, 2006. The USPS tracking system confirms that delivery was made on August 30, 2019. *See* Exhibit 4.

6. To date, A La Carte, Iron Sands, and TOPAW have not filed any answer or other response to the OIP or contacted Division counsel.
