DIVISION OF ENFORCEMENT’S MOTION FOR
DEFAULT AND BRIEF IN SUPPORT

The Division of Enforcement (“Division”), by counsel, pursuant to Commission Rules of Practice Rules 154(a) and 155(a)(2) respectfully moves the Securities and Exchange Commission (“Commission”) for an order entering a default against CannaSys, Inc. (“MJTK”) (CIK No. 1417028), China Modern Agricultural Information, Inc. (“CMCI”) (CIK No. 1479526) and Cinderella Target Value Zones Inc. f/k/a China Travel Resort Holdings, Inc. (“CTVZ”) (CIK No. 794929) (collectively “Respondents”) in this proceeding and ordering the revocation of the registration of each class of Respondents’ securities registered pursuant to Section 12 of the Securities Exchange Act of 1934 (“Exchange Act”).

Argument

On January 9, 2020, the Commission issued an Order Instituting Proceedings (“OIP”) against Respondents which have securities registered with the Commission under Section 12(g) of the Exchange Act. The OIP alleges the Respondents are delinquent in filing their mandated periodic reports. Because each of the Respondents failed to answer or otherwise

respond to the OIP, the Division now seeks entry of an order finding respondents MJTK, CMCI and CTVZ to be in default in this proceeding.

Commission Rule of Practice 220(b) states that where an answer is required to be filed by rule or order, the respondent “shall do so within 20 days after service upon the respondent of the order instituting proceedings” unless a different period is provided by rule or order. Here, the OIP requires “an Answer [to be filed] to the allegations contained in this Order within ten (10) days after service of this Order.” OIP at IV. Commission Rule of Practice 160(a) provides that Saturdays, Sundays and Federal legal holidays are to be counted as part of the 10 day period, and Commission Rule of Practice 160(b) extends that time by three days if service is made by mail.

The Declaration of Gina Joyce to Assist Secretary with Record of Service (attached hereto as Exhibit A) (“Joyce Declaration”) establishes that on January 11, 2020, service upon MJTK of the OIP, along with a letter from the Commission’s Secretary, and a letter from the Division offering discovery pursuant to Rule of Practice 230 (collectively the “Service Documents”), was attempted by Express Mail delivery at the address provided in its last EDGAR filing with the Commission, in accordance with Commission Rule of Practice 141(a)(2)(ii). MJTK’s answer to the OIP was due by Friday, January 24, 2020. However, MJTK has neither filed an answer nor made any other response to the OIP in this proceeding.

The Joyce Declaration also establishes that on February 7, 2020, CMCI was served with the Service Documents by Express Mail delivery at the address provided in its last EDGAR filing with the Commission, in accordance with Commission Rule of Practice 141(a)(2)(ii). CMCI’s answer to the OIP was due by Thursday, February 20, 2020. However, CMCI has neither filed an answer nor made any other response to the OIP in this proceeding.

The Joyce Declaration additionally establishes that on January 13, 2020, CTVZ was served with the Service Documents by Express Mail delivery at the address provided in its last EDGAR filing with the Commission, in accordance with Commission Rule of Practice 141(a)(2)(ii). CTVZ's answer to the OIP was due by Monday, January 27, 2020. However, CTVZ has neither filed an answer nor made any other response to the OIP in this proceeding.

The Respondents at issue are delinquent in their filings with the Commission and have been delinquent for more than a year. In addition, the Respondents' failure to answer supports revocation of the registration of each class of the Respondents' securities. Accordingly, the Division moves for an order, pursuant to Rule 155(a)(2), finding these Respondents to be in default in this proceeding and ordering that the registration of each class of their securities registered pursuant to Exchange Act Section 12 be revoked.

Conclusion

For the reasons set forth above, the Division respectfully requests that the Commission: 1) grant the Division's Motion; 2) enter an order of default against CannaSys, Inc., China Modern Agricultural Information, Inc., and Cinderella Target Value Zones Inc. f/k/a China Travel Resort Holdings, Inc.; and 3) revoke the registration of each class of their securities registered pursuant to Section 12 of the Exchange Act.

**DECLARATION OF GINA JOYCE
CONCERNING SERVICE UPON RESPONDENTS**

GINA JOYCE, pursuant to 28 U.S.C. § 1746, declares:

1. I am a Senior Counsel with the Division of Enforcement (“Division”) of the Securities and Exchange Commission, and co-counsel for the Division in the captioned administrative proceeding. I am submitting this Declaration to assist the Secretary in maintaining a record of service on the respondents in the captioned proceedings pursuant to Rule 141(a)(3).

2. Among other means, Securities and Exchange Commission (“Commission”) Rule of Practice 141(a)(2)(ii) permits service on a corporation or entity by delivering a copy of an Order Instituting Administrative Proceedings (“OIP”) to an agent authorized by appointment or law to receive such service or, in the case of an issuer with a class of securities registered with the Commission, by sending the OIP via U.S. Postal Service certified, registered, or Express Mail and obtaining a confirmation of attempted delivery on the most recent address shown on the entity’s most recent filing with the Commission.

Further, the OIP in this matter authorizes service of the OIP “by any means permitted by the Commission’s Rules of Practice.” Therefore, the Division asked the Commission’s Secretary to first attempt service on the Respondents via U.S. Priority Mail Express.

3. The Office of the Secretary provided me with the U.S. Priority Mail Express tracking numbers for the copies of the Order Instituting Proceedings (“OIP”)¹ that were mailed by the Secretary to the respondents in these proceedings. I input each of the tracking numbers into the U.S. Postal Service’s (“USPS’s”) package tracking system on its Internet website located at www.usps.com, and printed out the tracking confirmations in order to obtain confirmation of the delivery or attempted delivery of the OIP on each respondent. A true copy of the tracking confirmations for the respondents for whom express mail service was attempted by the Office of the Secretary is attached hereto as Exhibit 1.

4. The Secretary mailed the OIP to respondent CannaSys, Inc., CIK 1417028 (“MJTK”), via Priority Mail Express, Tracking No. EJ140717640US, to the address shown on its most recent EDGAR filing at 1350 17th Street, Suite 150, Denver, CO 80202. This address is taken from MJTK’s last filing with the Commission, which was a Form 8-K filed with the Commission on May 17, 2018. The USPS tracking system confirms that delivery was attempted on January 11, 2020. The addressee had moved, and left no forwarding address. The package was returned to the SEC. *See* Exhibit 1 at pp. 1 - 3.

5. The Secretary mailed the OIP to respondent Cinderella Target Value Zones Inc. f/k/a China Travel Resort Holdings, Inc., CIK 794929 (“CTVZ”), via Priority Mail

Express, Tracking No. EJ 140717622 US, to the address shown on its most recent EDGAR filing at 40 Wall Street, 28th Floor, New York, NY 10005. This address is taken from CTVZ's last filing with the Commission, which was a Form 10-Q filed with the Commission on September 27, 2019. The USPS tracking system confirms that the package was delivered on January 13, 2020. *See* Exhibit 1 at p. 4.


6. The last filing by Respondent China Modern Agricultural Information, Inc., CIK 1479526 ("CMCI") was an 8-K filed on May 24, 2018, which shows that it is headquartered at No. A09, Wuzhou Sun Town, Limin Avenue, Limin Development District, Harbin, Heilongjiang, China, 150000. A true and correct copy of a printout of the first page of CMCI's Form 8-K filed on May 24, 2018 is attached hereto as Exhibit 2. Though China is a signatory to the Hague Convention on the Service Abroad of Judicial and Extrajudicial Documents ("Hague Convention"), 20 U.S.T. 361, T.I.A.S. 6638, 658 U.N.T.A. 163 (1964), China objects to service by mail under Article 10(a). Thus, in order to serve the respondent in China, the Division would be required to have the document translated into Chinese and request the assistance of the Central Authority of China, a process which could delay service by more than a year. Therefore, the Division chose to first attempt service by means other than through the Hague Convention.

7. Exhibit 2 shows that CMCI is a Nevada corporation. A search of the website of the Nevada Secretary of State reveals that CMCI has a registered agent in the United States and that the name and address of CMCI's registered agent is Vcorp Services, 701 S. Carson Street, Suite 200, Carson City, NV, 89701. A true and correct copy of a of the summary pages from the website of the Nevada Secretary of State concerning CMCI are attached hereto as Exhibit 3.

8. On February 6, 2020, the Division sent a copy of the Order Instituting Proceedings in this matter, a letter from the Secretary, a letter from the Division concerning the availability of discovery, and the suspension release to CMCI's registered agent at the address set forth above, via Priority Mail Express, Tracking No. EI 283507748 US. A true and correct copy of the Priority Mail Express label is attached hereto as Exhibit 4. The package was delivered on February 7, 2020. A true and correct copy of the tracking confirmation for that delivery is attached hereto as Exhibit 5.

I declare under penalty of perjury that the foregoing is true and correct.

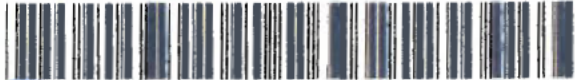
