**DIVISION OF ENFORCEMENT’S MOTION FOR**  
**DEFAULT AND BRIEF IN SUPPORT**

The Division of Enforcement (“Division”), by counsel, pursuant to Commission Rules of Practice Rules 154(a) and 155(a)(2), respectfully moves the Securities and Exchange Commission (“Commission”) for an order entering a default against IHO-AGRO International, Inc. n/k/a Grandwon Corp. (CIK No. 0001635538) (“GWON” or “Respondent”) in this proceeding and ordering the revocation of the registration of each class of Respondent’s securities registered pursuant to Section 12 of the Securities Exchange Act of 1934 (“Exchange Act”).

**Argument**

On September 10, 2020, the Commission issued an Order Instituting Proceedings (“OIP”) against Respondent, which has securities registered with the Commission under Section 12(g) of the Exchange Act. The OIP alleges the Respondent is delinquent in filing its mandated periodic reports. Because Respondent failed to answer or otherwise respond to the

OIP, the Division now seeks entry of an order finding Respondent to be in default in this proceeding.

Commission Rule of Practice 220(b) states that where an answer is required to be filed by rule or order, the respondent “shall do so within 20 days after service upon the respondent of the order instituting proceedings” unless a different period is provided by rule or order. Here, the OIP requires “an Answer [to be filed] to the allegations contained in this Order within ten (10) days after service of this Order.” OIP at IV. Commission Rule of Practice 160(a) provides that Saturdays, Sundays and Federal legal holidays are to be counted as part of the 10 day period, and Commission Rule of Practice 160(b) extends that time by three days if service is made by mail.

The Declaration of Ryan Farney to Assist Secretary with Record of Service (attached hereto as Exhibit A) (“Farney Declaration”) establishes that on March 11, 2021, GWON was served with the OIP by Priority Mail Express delivery to its registered agent, in accordance with Commission Rule of Practice 141(a)(2)(ii). GWON’s answer to the OIP was due by March 24, 2021. However, GWON has neither filed an answer nor made any other response to the OIP in this proceeding.

Respondent is delinquent in its filings with the Commission and has been delinquent for over three years. In addition, Respondent’s failure to answer supports revocation of the registration of each class of Respondent’s securities. Accordingly, the Division moves for an order, pursuant to Rule 155(a)(2), finding GWON to be in default in this proceeding and ordering that the registration of each class of its securities registered pursuant to Exchange Act Section 12 be revoked.

**Conclusion**

For the reasons set forth above, the Division respectfully requests that the Commission:

1) grant the Division's Motion; 2) enter an order of default against GWON; and 3) revoke the registration of each class of GWON's securities registered pursuant to Section 12 of the Exchange Act.



**DECLARATION OF RYAN FARNEY**  
**TO ASSIST SECRETARY WITH RECORD OF SERVICE**

RYAN FARNEY, pursuant to 28 U.S.C. § 1746, declares:

1. I am a Senior Counsel with the Division of Enforcement (“Division”) of the Securities and Exchange Commission, and counsel for the Division in the captioned administrative proceeding. I am submitting this Declaration to assist the Secretary in maintaining a record of service on the respondent in the captioned proceeding pursuant to Rule 141(a)(3).

2. The Office of the Secretary mailed the Order Instituting Proceedings (“OIP”) in this administrative proceeding to respondent IHO-AGRO International, Inc. (n/k/a Grandwon Corp.), CIK 0001635538 (“GWON”), via Priority Mail Express on or about September 11, 2000 to its registered agent, Vcorp Services, LLC, at 702 South Carson Street, Suite 200, Carson City, NV 89701. U.S. Postal Service tracking information indicates that the OIP was delivered on September 14, 2020; however, the address contained a typographical error.

3. On March 8, 2021, the OIP was mailed to GWON via Priority Mail Express, Tracking No. EJ591739628US, to Vcorp Services, LLC, at 701 South Carson Street, Suite 200, Carson City, NV 89701. A true copy of the tracking information for the OIP is attached as Exhibit 1 hereto. Rule 141(a)(2)(ii) permits service on a corporation or entity by delivering a copy of an OIP to an agent authorized by appointment or law to receive such service. Rule 141(a)(2)(iv) provides that “[n]otice of a proceeding to a person in a foreign country may be made by any method specified in paragraph (a)(2) of this rule, or by any other method reasonably calculated to give notice, provided that the method of service used is not prohibited by the law of the foreign country.”

4. The last EDGAR filing by GWON was a Form 8-K filed on January 12, 2018 and dated January 5, 2018. A true copy of the Form 8-K is attached as Exhibit 2 (exhibits to Form 8-K omitted). The Form 8-K provided an address for GWON in Guangdong, China and indicated Nevada as GWON’s state of incorporation. *See* Exhibit 2 at page 1.

5. Attached as Exhibit 3 is a true copy of a printout I made from the Nevada Secretary of State’s website (esos.nv.gov) on March 29, 2021, indicating that GWON’s registered agent is Vcorp Services, LLC, 701 South Carson Street, Suite 200, Carson City, NV 89701. *See* Exhibit 3 at pages 2-3.

6. The U.S. Postal Service’s tracking system confirms that the OIP was delivered on March 11, 2021. *See* Exhibit 1 at page 1.



#### **Item 4.01. Changes in Registrant’s Certifying Accountant**

##### **(a) Resignation of Independent Registered Accounting Firm**

On January 5, 2018, MaloneBailey LLP (“MaloneBailey”) tendered its resignation as the independent registered public accounting firm of IHO-Agro International, Inc. (the “Company”). MaloneBailey’s resignation as the Company’s independent auditor. The Company has engaged the certified public accounting firm of WWC, P.C. as its new auditor.

MaloneBailey’s reports on the Company’s consolidated financial statements for the fiscal years ended September 30, 2016 and 2015 did not contain an adverse opinion or a disclaimer of opinion and were not qualified or modified as to uncertainty, audit scope or accounting principles, except that the report included an explanatory paragraph relating to an uncertainty as to the Company’s ability to continue as a going concern. Furthermore, during the Company’s two most recent fiscal years and through January 5, 2018, there have been no disagreements with MaloneBailey on any matter of accounting principles or practices, financial statement disclosure or auditing scope or procedure, which disagreements, if not resolved to MaloneBailey’s satisfaction, would have caused MaloneBailey to make reference to the subject matter of the disagreement in connection with its reports on the Company’s consolidated financial statements for such periods.

For the years ended September 30, 2016 and 2015 and through January 5, 2018, there were no “reportable events” as that term is described in Item 304(a)(1)(v) of Regulation S-K except MaloneBailey having advised the Company that it identified certain deficiencies in the Company’s internal control over financial reporting that constitute a material weaknesses as described in Item 9A of the Company’s annual report on Form 10-K for the year ended September 30, 2016.

The Company has provided MaloneBailey with a copy of the foregoing disclosure prior to its filing with the Securities and Exchange Commission (the “Commission”) and requested that MaloneBailey furnish the Company a letter addressed to the Commission stating whether or not it agrees with the statements above and, if not, stating the respects in which it does not agree. A copy of MaloneBailey letter to the Commission is attached as an exhibit to this current report on Form 8-K. A copy of the Company’s letter engaging WWC, L.L.C. is also attached as an exhibit to this current report.
