DIVISION OF ENFORCEMENT'S MOTION FOR <u>DEFAULT AND BRIEF IN SUPPORT</u>

The Division of Enforcement ("Division"), by counsel, pursuant to Commission Rules of Practice Rules 154(a) and 155(a)(2), respectfully moves the Securities and Exchange Commission ("Commission") for an order entering a default against Royale Globe Holding Inc. (CIK No. 0001383145) ("Royale" or "Respondent") in this proceeding and ordering the revocation of the registration of each class of Respondent's securities registered pursuant to Section 12 of the Securities Exchange Act of 1934 ("Exchange Act").

Argument

On September 11, 2020, the Commission issued an Order Instituting Proceedings ("OIP") against Respondent, which has securities registered with the Commission under Section 12(g) of the Exchange Act. The OIP alleges the Respondent is delinquent in filing its mandated periodic reports. Because Respondent failed to answer or otherwise respond to the OIP, the Division now seeks entry of an order finding Respondent to be in default in this proceeding. Commission Rule of Practice 220(b) states that where an answer is required to be filed by rule or order, the respondent "shall do so within 20 days after service upon the respondent of the order instituting proceedings" unless a different period is provided by rule or order. Here, the OIP requires "an Answer [to be filed] to the allegations contained in this Order within ten (10) days after service of this Order." OIP at IV. Commission Rule of Practice 160(a) provides that Saturdays, Sundays and Federal legal holidays are to be counted as part of the 10 day period, and Commission Rule of Practice 160(b) extends that time by three days if service is made by mail.

The Declaration of Victor Tabak to Assist Secretary with Record of Service (attached hereto as Exhibit A) ("Tabak Declaration") establishes that on September 15, 2020, Royale was served with the OIP by Priority Mail Express delivery at the address of Royale's registered agent, in accordance with Commission Rule of Practice 141(a)(2)(ii). Royale's answer to the OIP was due by September 28, 2020. However, Royale has neither filed an answer nor made any other response to the OIP in this proceeding.

Respondent is delinquent in its filings with the Commission and has been delinquent for over five years. In addition, Respondent's failure to answer supports revocation of the registration of each class of Respondent's securities. Accordingly, the Division moves for an order, pursuant to Rule 155(a)(2), finding Royale to be in default in this proceeding and ordering that the registration of each class of its securities registered pursuant to Exchange Act Section 12 be revoked.

Conclusion

For the reasons set forth above, the Division respectfully requests that the Commission:

1) grant the Division's Motion; 2) enter an order of default against Royale; and 3) revoke the

registration of each class of Royale's securities registered pursuant to Section 12 of the Exchange

Act.

DECLARATION OF VICTOR TABAK TO ASSIST SECRETARY WITH RECORD OF SERVICE

VICTOR TABAK, pursuant to 28 U.S.C. § 1746, declares:

1. I am a Senior Counsel with the Division of Enforcement ("Division") of the Securities and Exchange Commission, and co-counsel for the Division in the captioned administrative proceeding. I am submitting this Declaration to assist the Secretary in maintaining a record of service on the respondent in the captioned proceeding pursuant to Rule 141(a)(3).

2. The Office of the Secretary provided me with the U.S. Priority Mail Express tracking number for the copy of the Order Instituting Proceedings ("OIP") mailed by the Secretary to the respondent in this proceeding. I input the tracking number into the U.S. Postal Service's ("USPS's") package tracking system on its Internet website located at <u>www.usps.com</u>, and printed out the tracking confirmation in order to obtain confirmation of the delivery or attempted delivery of the OIP on the respondent. A true copy of the tracking confirmation for the respondent is attached as Exhibit 1, hereto.

3. As Exhibit 2 at 1 states, Royale Globe Holding, Inc., CIK 0001383145 ("Royale"), has a revoked status with the State of Nevada. Nev. Rev. Stat. §78.750 provides that service on a revoked Nevada corporation may be accomplished by service on "(a) the registered agent of the corporation, if there is one; and (b) each officer and director of the corporation as named in the list last filed with the Secretary of State before the dissolution or expiration of the corporation or the forfeiture of its charter." Notwithstanding the statute's use of the word "and", the Nevada Supreme Court has interpreted the "and" to include "or", and held that the listed recipients are alternative recipients of service. *Canarelli v. Eighth Jud. Dist. Ct. of Nev.*, 265 P.3d 673, 675 n.2 (Nev. 2011).

4. The Secretary mailed the OIP to respondent Royale's registered agent for service of process, via Priority Mail Express, Tracking No. EJ435622885, to the address shown on Exhibit 2: c/o Empire Stock Transfer, Inc., Registered Agent, 1859 Whitney Mesa Drive, Henderson, NV 89014. The USPS tracking system confirms that the package was delivered on September 15, 2020. *See* Exhibit 1 at page 1.
