- 1. I am the CEO of the Respondent.
- 2. I assert a threefold defense in Opposition to Revocation of Respondent's Registration:
 - a. Firstly; I timely responded to the Commission requests concerning delinquent filings.
 - b. I have attached hereto Exhibits A and B the documents which set forth my timely response to the Commission.
 - c. Secondly, since February 2020 I have been in Malaysia unable to return to the United States due to COVID restrictions. I have detailed those COVID related events in Exhibit A.

d. Affiant's third defense is that Respondent's financial adviser NYX Advisors had been engaged to prepare and report Respondent's filings; but despite being properly and timely compensated; the financial adviser failed and refused to prepare and file such reports

e. When Affiant discovered that NYX did not prepare and file Respondent's filings; I immediately made arrangements to engage a new firm to prepare and file the Respondent's reports.

f. The current financials for Respondent are all prepared and are waiting upload to OTCIQ Link (pending OTC Markets approval of Respondent's application).

	Dates	Remarks		
1	January 2020	Eight Chinese nationals were quarantined at a hotel inMalaysia on 24 January 2020 after coming into contact with an infected person in neighbouring Singapore. The Malaysian public were reminded by local authorities to take precautionary measures in the wake of the virus threat. Nevertheless as CEO I took the risks of going to USA in February 2020.		
2	February 18-27, 2020	My last trip to USA was from Feb 18-27 2020. When I left New York city on Feb 27 2020, the first case of COVID-19 in New York was confirmed two days later on March 1, 2020, and the state quickly became an epicenter of the pandemic.		
3	March 2020	As widely expected, Malaysian authorities banned traveling abroad for Malaysian citizens - on March 16, 2020, the Prime Minister announced a nationwide lockdown known as the Movement Control Order (MCO) which has been repeatedly extended in some form or other and this lasted to this date which effectively does not allow Malaysians to travel outside of Malaysia unless for dire emergencies. Our businesses are based in Indonesia, Hong Kong and the USA and we were unable to travel, even to visit the banks or accountants in many cases.		
4	April 21, 2020	Received a delinquency email from SEC which we immediately replied the next day on April 22, 2020		
5	May 4, 2020	SMRN sent official explanatory letter on May 4, 2020 to SEC explaining the reasons and difficulties for the delinquency. We did not hear anything from SEC at all until the recent SEC action to suspend trading.		
6	Current	CEO is still unable to leave Malaysia to date due to Malaysian government restrictions against traveling abroad.

Smartag International has fallen behind due to financial issues, which issues are being dealt with as we write this response. Financial constraints have arisen compounded by the current pandemic situation that even our long standing attorney who was filing the report, Attorney Eric Stoppenhagen, (http://stoppenhagen.com/), is having a dispute with us over his current invoices in order to get his cooperation in providing the company records up to and including the information from the last filing, 10K, on January 14, 2019.

It will not be possible to bring the company current within the next 15 days. The company would need to file four (4) 10Q's and one (1) 10K to bring the company current and with the information available that is not possible. In the meantime we are working to reconstruct the financial records to move forward with a new accounting and legal team.

We respectfully request additional time during these trying times to get the accounting squared away and the past due reports filed.
