1. I am the CEO of Respondent; SmarTag International Inc. ("SMRN").
2. I assert the following in Opposition to the Division of Enforcement's Motion for Summary Disposition; towit: SMRN has brought current the deficiencies cited by the Division of Enforcement, namely :
  - a. The Respondent has brought current its corporate filing in Nevada.
  - b. The financials have been brought current and are uploaded to OTCIQ Link.
  - c. Thus, the main reasons for the Commission's action against the Respondent; i.e., lack of current information is cured.
3. Secondly, although the Commission has made allowances for delayed filings due to COVID-19; since February 2020 I have been in Malaysia unable to return to the United States due to the COVID travel ban. This travel ban has made conducting business in

the normal course difficult at best and truly extremely difficult.
