DIVISION OF ENFORCEMENT'S MOTION TO THE COMMISSION TO DISMISS AND BRIEF IN SUPPORT

The Division of Enforcement ("Division"), by counsel, hereby moves the Commission to dismiss this administrative proceeding, which was brought pursuant to Section 12(j) of the Securities Exchange Act of 1934 ("Exchange Act") to suspend or revoke STRATABASE's securities registration.

As explained below, the Division seeks this relief because STRATABASE's successor corporation, Strata Power Corporation, is up to date in its periodic filings with the Commission.

Background and Argument

The Commission initiated this administrative proceeding on September 22, 2020, against STRATABASE. On June 9, 2021, counsel for the Division spoke with counsel for Strata Power Corporation, who noted that STRATABASE moved to Canada in 2004 and changed its name to Strata Oil & Gas Inc. (n/k/a Strata Power Corporation). According to Counsel for the Strata Power Corporation, STRATABASE inadvertently changed CIK numbers when it moved to

Canada, it also changed its name, and became a 20-F filer. Strata Power Corporation (f/k/a Strata Oil & Gas, Inc.) only became aware of this pending administrative proceeding, and the

existence of the multiple CIKs, in recent weeks.

The Division then confirmed the representations made by counsel for Strata Power

Corporation through speaking with personnel in the Division of Corporation Finance and

reviewing the records of Strata Power Corporation's filings on the Commission's EDGAR

system.

The Division respectfully submits that this administrative proceeding should be dismissed

because STRATABASE's successor entity, Strata Power Corporation was up to date in its

periodic filings at the time that this proceeding was instituted and remains current as of the date

of this Motion. Accordingly, the administrative proceeding should be dismissed.

Conclusion

For the reasons set forth above, the Division respectfully requests that the Commission

dismiss this proceeding.
