**NOTICE OF SECOND FAILURE TO OPPOSE**  
**MOTION BY DIVISION OF ENFORCEMENT**  
**FOR SUMMARY DISPOSITION AGAINST**  
**RESPONDENTS WESLEY KYLE PERKINS AND**  
**WORLD TREE FINANCIAL, LLC**

The Division of Enforcement (“Division”) filed its motion for summary disposition in this follow-on proceeding against Wesley Kyle Perkins (“Perkins”) and World Tree Financial LLC (“World Tree”) on August 19, 2022. Respondents’ opposition was due on September 16, 2022. On September 6, 2022, Respondents’ counsel filed a motion to withdraw as counsel. Respondents did not respond to the Division’s motion for summary disposition. On September 27, 2022, the Division filed a notice of failure to oppose.

On November 8, 2022, the Commission issued an order denying Respondents’ counsel’s motion to withdraw, and extended the time to oppose the Division’s motion for summary disposition to December 6, 2022. Once again, Respondents failed to oppose.

Accordingly, for all the reasons set forth in the Division’s motion, summary disposition should be granted and Respondents should be barred from association with any broker, dealer, investment adviser, municipal securities dealer, municipal advisor, transfer agent, and nationally recognized statistical rating organization, and, as to Perkins, from participating in any offering of penny stock.
