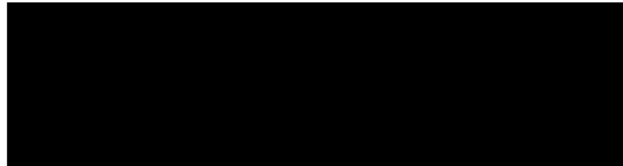

corporation or entity may be obtained by confirmation of attempted delivery on the most recent address shown on the entity's most recent filing with the Commission.

The Secretary mailed the OIP to respondent SPECTRASCIENCE, INC., CIK 727672 ("SCIE"), via Priority Mail Express, Tracking No. EJ435623673US, to the address shown on its most recent EDGAR filing at 11568 Sorrento Valley Rd., Suite 11 San Diego, California 92121. This address is taken from SCIE's last filing with the Commission, which was a Form DEF 14C filed with the Commission on November 27, 2017. The USPS tracking system confirms that delivery was attempted on May 20, 2021 and that notice left. *See* Exhibit 1 at page 2.
