DIVISION OF ENFORCEMENT'S RESPONSE TO DF GROWTH REIT II, LLC'S MOTION FOR AN ORDER TO SHOW CAUSE

The Division of Enforcement ("Division") submits this Response to Respondent DF Growth REIT II's (the "Respondent" or "REIT II") Motion for an Order to Show Cause, served on July 7, 2022.

I. INTRODUCTION

On July 7, 2022, Respondent filed a Motion for an Order to Show Cause Why the Enforcement Division Should Not Be Sanctioned for (1) (Apparently) Failing to Serve Respondent DF Growth REIT II, LLC with its Reply Brief and (2) (Apparently) Failing to Include a Certificate of Service with its Filing. The Respondent's Motion contains multiple inaccuracies to the Court and should be denied.

Respondent states that the Division did not file a Reply brief and that "June 28, 2022 came and went . . . without Respondent or counsel receiving anything whatsoever from the Division." This statement is false. In fact, a paralegal with the Division filed the Division's Reply on June 28, 2022. *See* Exhibit 1. The same paralegal then served the Division's Reply on all defense counsel of record at 4:38 PM PST and forwarded the notice of filing on June 28, 2022. *See* Exhibit 2. While the Division's Reply inadvertently did not include a Certificate of Service, defense counsel was not prejudiced in any way as defense counsel were contemporaneously served with the Division's Reply at the time of filing. ¹

Respondent's aim in submitting its Motion is evident: it wants an opportunity to file a sur-reply to the Division's Motion for Summary Disposition, even though the motion has been fully briefed and Respondent has no right to file a sur-reply. Respondent attempts this

¹ Respondent does not dispute in its Motion the manner in which it was served. In any case, the Division notes that both parties throughout the course of this litigation have exclusively served filings on the opposing party through email. In fact, Respondent acknowledges that it was "properly served" with the Division's Motion for Summary Disposition, by which she was served by email.

misdirection by re-characterizing the Division's Reply brief as an "opposition brief" and tells the Court that it "wishes to reply to the opposition brief that it can only assume the Division filed well over a week ago." Respondent's Motion at 6. However, the case schedule adopted by the Court provides for no such briefing.

The Court's order adopting the parties' proposed case schedule set the deadline for filing "Motions for summary disposition" on June 3, 2022, the deadline for filing "Oppositions to motions for summary disposition" on June 20, 2022, and the deadline for filing "Summary disposition replies" on June 27, 2022. While the Division filed a motion for summary disposition on June 3, 2022, the Respondent elected to not file its own disposition motion.

Respondent then filed an opposition to the Division's motion for summary disposition on June 21, 2022.² Respondent was then served with the "Division of Enforcement's Reply to DF Growth REIT II, LLC's Response to the Division's Motion for Summary Disposition" on June 28, 2022.

In short, Respondent misrepresents to the Court that it did not receive the Division's Reply (which it did), and then seeks to use the inadvertent omission of a Certificate of Service as an excuse to ask the Court for the opportunity to file a sur-reply, which is not permitted under the Commission Rules of Practice or under the Court's scheduling order.

² Due to the Juneteenth federal holiday, Respondent filed its opposition to the Division's Motion for Summary Disposition on June 21st and the Division filed its Reply on June 28th.

II. <u>CONCLUSION</u>

For the foregoing reasons, the Division respectfully requests that the Court deny REIT II's Motion for an Order to Show Cause and permanently suspend REIT II from its continued use of Regulation A.


