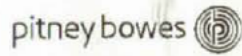

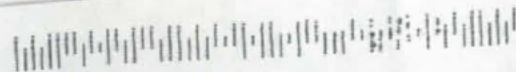

SECTION 17A(c)(4)(B) OF THE ACT

18 Respondents **IHSAN DARIUSH IBRAHIM GHOLIZADEH INC., and IHSAN DARIUSH**
19 **IBRAHIM GHOLIZADEH TRANSFER TRUST**, (“Organizations” or “Trust”) hereby
20 humbly requests the cancelation, termination of Transfer Agent Registrations and ALL
21 connected and subsequent filings and requests removal of all public records associated with
22 respondents. Respondents deem it appropriate and in the public and private interests of all parties
23 that these relations end.

24 **II.**

25 **A. FACTS**

- 26 1.) The organizations computer, physical records containing the passwords for the email and
27 the EDGAR system access codes where unfortunately lost to water damage and
28 ineligible.
- 2.) Organization was unfortunately not able to access the EDGAR system since the last sign
in and currently has NO way to access them and therefore did not receive SEC electronic

2 requests for amendments/corrections referred to in complaint and therefor was not aware
3 of commissions request, due to lack of proper experience in navigating the EDGAR
4 system.

5
6 3.) Organization currently has no way to access the eFAP system or EDGAR so physical
7 copies of this response will be mailed using USPS certified mail, return receipt to all
8 parties.

9
10 4.) Since the initial TA-1 applications were submitted to SEC, NO Transfer agent activities
11 have occurred and subsequently no records of such events would be able to be provided
12 because none exist.

13
14 5.) Since no transactions and no transfer agent activities were made, we were not aware that
15 any annual reports needed to be reported. This we now know was an error since
16 becoming more familiar with rules. We humbly ask for forgiveness, this was a mistake.

18 6.) It was not our intent to not comply or to not submit annual report, records, and
19 amendment, SEC requested. This was caused by a general lack of understanding of the
20 rules and was NOT a Willful act, and we reemphasize it was a Mistake.

III.

B. RESPONSE TO VIOLATIONS

In section D. paragraph 20, 21, 22, 23, 24 the Commission alleges that respondents willfully
violated the rules and while respondents acknowledge and accept the facts there where
unforeseeable events that constitute a defense as stated in the Section II. (FACTS) of this
response but because respondents do not wish to cause controversy where one does not exist,
we have accepted your claim and return delivery for settlement of this matter. We would
however respectfully wish to clarify the matter of Intent. The term “*willful*” refers to acts
which are intentional, conscious, voluntary, and designed to achieve a particular result. We
can assure the commission this was not the case.

5 **C. PRAYER FOR RELIEF**

6 We are respectfully requesting and authorizing the commission to cancel, terminate and
7 withdraw said registrations for these organizations. We have not and will not be doing any
8 transfer agent business/services anytime soon. In hindsight this should have been requested
9 long ago since these organizations have ceased doing business. Section 17A(c)(4)(B) of the
10 Act provides that if the Commission finds that any transfer agent registered with the
11 Commission is no longer in existence or has ceased to do business as a transfer agent, the
12 Commission shall by order cancel that transfer agent's registration.

13 Again, this request is due to organizations computer and EDGAR access codes damaged and
14 lost, no way to access EDGAR and our lack of experience in navigating the EDGAR system
15 (filing forms etc.) and do not wish to complicate this matter any further. In the future if we
16 wish to register these organization(s) again we will seek competent professional assistance
17 to avoid such mistakes. Please send back confirmation of cancelation of said TA-1 and ALL
18 connected and subsequent filings and delete all public records from registry as soon as
19 possible.

20 **We pray that this is a sufficient response to your request.**
