DIVISION OF ENFORCEMENT'S TENTH STATUS REPORT CONCERNING SERVICE OF ORDER INSTITUTING ADMINISTRATIVE PROCEEDINGS

The Division of Enforcement ("Division") respectfully submits its tenth status report pursuant to the Order Regarding Service dated February 15, 2023, and states as follows:

As set forth in the Ninth Status Report, the Division provided Spanish authorities with a copy of Respondent's Documento Nacional de Identidad in an attempt to locate any real property in which Respondent has an ownership interest as a means to effect service in response to the Division's Hague Service Convention request. On or about October 10, 2023, the Division was notified that the Spanish authorities were unable to locate any property in Respondent's name. The Division now is in the process of coordinating with the Department of Justice's Office of Foreign Litigation to further assist in attempting to effect personal service on Respondent.

In the meantime, counsel for the Division again attempted to contact Respondent on November 3, 2023 at **Sector Sector Sec** The Division will continue its efforts to contact and serve Respondent, including by coordinating with the Spanish authorities and the Office of Foreign Litigation. If such efforts to serve Respondent are unsuccessful, the Division will continue to evaluate whether it may be appropriate to seek leave to effect service by alternative means consistent with SEC Rule of Practice 141.

Pursuant to the Order Regarding Service dated February 15, 2023, the Division will file a further status report on December 1, 2023.
