The Division of Enforcement (the “Division”) respectfully submits this Status Report pursuant to the Commission’s November 26, 2024 Order Directing Status Report from the Division. *See Christopher Byungin Lee*, Securities Exchange Act Rel. No. 101753 (Nov. 26, 2023) (the “Order”).

As noted in the Division’s Status Report filed on February 4, 2025, the Division had not been able to serve the order instituting proceedings (“OIP”) on Respondent Christopher Byungin Lee (“Lee”) despite engaging a process server to follow up on substantial prior efforts.

After filing the Status Report on February 4, 2025, Lee was served personally on February 21, 2025, at [REDACTED], [REDACTED]. The Return of Service, which documents the details surrounding the service of the OIP on Lee, is attached as Exhibit A.
