SUPPLEMENTAL DECLARATION OF GINA JOYCE
TO ASSIST SECRETARY WITH RECORD OF SERVICE

GINA JOYCE, pursuant to 28 U.S.C. § 1746, declares:

1. I am a Senior Counsel with the Division of Enforcement (“Division”) of the Securities and Exchange Commission, and co-counsel for the Division in the captioned administrative proceeding. I am submitting this Supplemental Declaration to assist the Secretary in maintaining a record of service on the Respondent in the captioned proceedings pursuant to Rule 141(a)(3).
2. Among other means, Securities and Exchange Commission (“Commission”) Rule of Practice 141(a)(2)(ii) permits service on a corporation or entity by delivering a copy of an Order Instituting Administrative Proceedings (“OIP”) to an agent authorized by appointment or law to receive such service or, in the case of an issuer with a class of securities registered with the Commission, by sending the OIP via U.S. Postal Service certified, registered, or express mail and obtaining a confirmation of attempted delivery on the most recent address shown on the entity’s most recent filing with the Commission.

3. The most recent filing by Respondent Krupp Cash Plus Ltd Partnership, CIK 768175 (“KCPLP”) is a Form 10-Q filed with the Commission on November 12, 1998. A true copy of the face page of the Form 10-Q is attached hereto as Exhibit 1.

4. Exhibit 1 shows that KCPLP’s the most recent address shown on its most recent filing is 470 Atlantic Avenue, Boston, MA 02210. As set forth in my September 21, 2023 Declaration, delivery of the OIP package was attempted on September 2, 2023.

5. Nonetheless, on November 2, 2023, the Commission issued an Order Regarding Service which stated that the address should include the line “c/o Berkshire Realty Affiliates,” and that directed me to submit a supplemental declaration by November 16, 2023.

6. On November 2, 2023, I requested that the Mailroom send the OIP, along with a party letter and AP filing instructions to KCPLP, c/o Berkshire Realty Affiliates, 470 Atlantic Avenue, Boston, MA 02210, via Priority Mail Express. A true copy of the Priority Mail Express label is attached hereto as Exhibit 2.

7. Exhibit 2 shows that the tracking number is EI 395 828 963 US. The USPS tracking system confirms that delivery of the OIP package was attempted on November 6, 2023, but the addressee was unknown. A true copy of the tracking confirmation for the Respondent on which Priority Mail Express service was attempted is attached as Exhibit 3, hereto.

I declare under penalty of perjury that the foregoing is true and correct.
