DIVISION OF ENFORCEMENT’S MOTION TO DISMISS
ADMINISTRATIVE PROCEEDING AND BRIEF IN SUPPORT

Pursuant to the February 7, 2024 Order Directing Additional Briefing issued by the Securities and Exchange Commission (“Commission”), the Division of Enforcement (“Division”), by counsel, hereby moves to dismiss this administrative proceeding brought pursuant to Section 12(j) of the Securities Exchange Act of 1934 (“Exchange Act”). The Respondent, Nano World Projects Corp. (“Nano World” or “Respondent”) is no longer registered under Exchange Act Section 12, and under the circumstances discussed below, the Division believes it is appropriate to dismiss this administrative proceeding.

Brief in Support

On May 20, 2003, an administrative law judge issued an initial decision ordering that the registration of the common stock of Nano World be revoked, and the Initial Decision became the final decision of the Commission on June 18, 2003. *Nano World Projects Corp.*, Exchange Act Release No. 48057, 2003 WL 21398201 (June 18, 2003) (finality notice). The 2003 revocation was not reflected in EDGAR. At the Division’s recommendation, on August 31, 2023, the Commission instituted proceedings against Nano World for revocation of the registration of its

securities. In light of the procedural background above, and the fact that the registration of Nano World's securities has already been revoked, the Division believes it is appropriate to dismiss the instant proceeding.

Conclusion

For the reasons set forth above, the Division respectfully requests that the Commission order the dismissal of this administrative proceeding against Respondent Nano World.
