DECLARATION OF SANDHYA C. HARRIS
TO ASSIST SECRETARY WITH RECORD OF SERVICE

SANDHYA C. HARRIS, pursuant to 28 U.S.C. § 1746, declares:

1. I am a Senior Counsel with the Division of Enforcement (“Division”) of the Securities and Exchange Commission, and co-counsel for the Division in the captioned administrative proceeding. I am submitting this Declaration to assist the Secretary in maintaining a record of service on the respondent in the captioned proceeding pursuant to Rule 141(a)(3).

2. The address shown in JS BEAUTY LAND NETWORK TECHNOLOGY INC.’s (“JSBL”) last filing with the Commission, a Form 8-K filed on July 28, 2022, was in the People’s Republic of China (“China”). Though China is a signatory to the Hague Convention on the Service Abroad of Judicial and Extrajudicial Documents (“Hague Convention”), 20 U.S.T. 361, T.I.A.S. 6638, 658 U.N.T.A. 163 (1964), it objects to service by mail under Article 10(a). Thus, in order to perfect service on JSBL in China, the Division would be required to have the

document translated into Chinese and request the assistance of the Central Authority of China, a process which could delay service by more than a year. Therefore, the Division chose to first attempt service by means other than through the Hague Convention.

3. Although its last address is in China, JSBL is a Nevada corporation. A search of the website of the Nevada Secretary of State revealed that name and address of JSBL's registered agent is INCORP SERVICES, INC. [REDACTED]

[REDACTED] A true copy of the printout of the first page of JSBL's corporate status page from that website is attached hereto at Exhibit 1. Therefore, the Division provided this address to the Office of the Secretary and requested that the Secretary attempt service on JSBL's Nevada registered agent via Certified Mail. The Secretary mailed the OIP to JSBL's registered agent at the address referenced above via Certified Mail, tracking number 7017240000008363977. The USPS tracking system confirms that it was delivered on September 19, 2023. See Exhibit 2.

I declare under penalty of perjury that the foregoing is true and correct.
