**DECLARATION OF SANDHYA C. HARRIS**  
**TO ASSIST SECRETARY WITH RECORD OF SERVICE**

SANDHYA C. HARRIS, pursuant to 28 U.S.C. § 1746, declares:


1. I am a Senior Counsel with the Division of Enforcement (“Division”) of the Securities and Exchange Commission, and co-counsel for the Division in the captioned administrative proceeding. I am submitting this Declaration to assist the Secretary in maintaining a record of service on the respondent in the captioned proceeding pursuant to Rule 141(a)(3).
2. The Office of the Secretary provided me with the International Registered Mail tracking number for the copy of the Order Instituting Proceedings (“OIP”) mailed by the Secretary to the respondent in this proceeding. Rule 141(a)(2)(ii) provides that service on a corporation or entity may be obtained by confirmation of attempted delivery on the most recent address shown on the entity’s most recent filing with the Commission.
3. I input the Certified Mail tracking number provided by the Office of the Secretary into the U.S. Postal Service’s (“USPS’s”) package tracking system on its Internet website located

at [www.usps.com](http://www.usps.com), in order to obtain confirmation of the delivery or attempted delivery of the OIP on the respondent, however I found that the service package was still in transit as of October 31, 2023. Rule 141(a)(2)(ii) also provides that service may be made by delivering a copy of the OIP to an officer, managing or general agent, or any other agent authorized by appointment or by law to receive such notice. Respondent Kibush Capital Corp.'s, CIK 1614466 ("DLCR") is a Nevada registered corporation. A search of the Nevada Secretary of State website revealed that the name and address of DLCR's registered agent are Northwest Registered Agent, LLC., 401 RYLAND ST STE 200-A, Reno, NV, 89502, USA. A true copy of a printout of the first page of DLCR's corporate status page from that website is attached hereto as Exhibit 1.

4. In order to perfect service, I mailed another copy of the OIP, via Priority Mail Express, Tracking No. EJ127657249US, to DLCR's registered agent at the address listed above, The USPS tracking system confirms that it was delivered on November 1, 2023. *See* Exhibit 2 at page 1.

I declare under penalty of perjury that the foregoing is true and correct.
