ALPINE SECURITIES CORPORATION (“Alpine”) hereby amends its Application for Review dated April 30, 2024 to include a subsequent decision entered by DTCC on September 19, 2024 ordering Alpine to pay \$261,263.22 in “costs” associated with the underlying proceeding (order attached as Exhibit A). Alpine seeks review of each and every aspect of the September 19th decision including: (1) whether the determination that attorney fees, which represent \$233,539.00 of the ordered total, were properly ordered under a provision that allows for recovery of costs; (2) whether DTCC properly exercised its discretion in ordering Alpine to pay costs; and (3) whether the amounts charged by counsel for the DTCC panel were appropriate based on the nature of the proceeding.
