Good Morning Ms. Williams and Harris:

It has been some time since we last corresponded but at that time we discussed 13 months for me to bring the company (Daniels Corporate Advisory company) current even though I should have never been in Enforcement in the first place. In any event, I am still in the time period allotted and do not understand the contents of the official letter I received on Saturday June 27,2025

I would never not respond or agree to the ending of the Registration rights. I was never a shell company. I was an operating company. At our last SEC filing valuable hard assets were noted on the books including back salary of at least \$1,500,000 that would have to be paid to me over time in any deal that extends the operating life of DCAC (Daniels). I am actively pursuing deals (and will continue to do so) for the restructuring of "Daniels" once my health improves. Serious issues cropped up over the last two months. Issues that slowed business issues.

Over the last two months I have experienced severe breathing issues which I tried to manage at home. It came to a point where this was not possible, as I did not know what I was dealing with. Medical care was the only option. I have been hospitalized in NYU Langone (in Manhattan, first in emergency then as a patient (Dr. Vetrano PCP) and then a second time at Northwell Health (Long Island Jewish) Patient # [REDACTED] in Forest Hills Queens. In both hospitals doctors were concerned that an 80 year old patient had [REDACTED] - [REDACTED] which became more severe at Northwell when further testing uncovered not only viral lung problems but [REDACTED] as well. Medication has remedied both situations. I am feeling okay and ready to attend to business once again.
