DECLARATION OF SANDHYA C. HARRIS
TO ASSIST SECRETARY WITH RECORD OF SERVICE

SANDHYA C. HARRIS, pursuant to 28 U.S.C. § 1746, declares:

1. I am a Senior Counsel with the Division of Enforcement (“Division”) of the Securities and Exchange Commission, and co-counsel for the Division in the captioned administrative proceeding. I am submitting this Declaration to assist the Secretary in maintaining a record of service on the respondent in the captioned proceeding pursuant to Rule 141(a)(3).

2. The Office of the Secretary provided me with the U.S. Certified Mail tracking number for the copy of the Order Instituting Proceedings (“OIP”) mailed by the Secretary to the respondent in this proceeding. I input the tracking number into the U.S. Postal Service’s (“USPS’s”) package tracking system on its Internet website located at www.usps.com, and printed out the tracking confirmation in order to obtain confirmation of the delivery or attempted delivery of the OIP on the respondent. A true copy of the tracking confirmation for the respondent is attached as Exhibit 1, hereto. Rule 141(a)(2)(ii) provides that service on a


corporation or entity may be obtained by confirmation of attempted delivery on the most recent address shown on the entity's most recent filing with the Commission.

3. The Secretary mailed the OIP to respondent QUANTRX BIOMEDICAL CORPORATION, CIK 820608 ("QTXB"), via Certified Mail, Tracking No. 7016 0910 0001 6656 0736, to the address shown on its most recent EDGAR filing at 10190 SW 90th Avenue Tualatin, Oregon 97062. This address is taken from QTXB's last filing with the Commission, which was a Form 10-Q filed with the Commission on November 14, 2022. The USPS tracking system confirmed that the package was returned to sender, however it did not provide sufficient detail as to the delivery attempt. *See Exhibit 1 at page 2.*

4. In order to perfect service, I mailed another copy of the service package to the Respondent at the address referenced above, via Priority Mail Express, Tracking No. EJ127655716US. The USPS tracking system confirmed that delivery was attempted on September 19, 2024 but that there was "no such number" and the package was returned to sender. *See Exhibit 1 at page 5.*

I declare under penalty of perjury that the foregoing is true and correct.
