**DIVISION OF ENFORCEMENT'S
SECOND NOTICE REGARDING
STATUS OF SERVICE**

The Division of Enforcement files this Second Notice Regarding the Status of Service of the OIP in this matter and states as follows.

1. On September 25, 2024, the Commission instituted this proceeding by issuing an Order Instituting Administrative Proceedings Pursuant to Section 15(b) of the Securities Exchange Act of 1934 and Notice of Hearing (the "OIP").

2. On or about October 3, 2024, and pursuant to Rule 141 of the Commission's Rules of Practice, the Division of Enforcement ("DOE") instructed Cavalier Courier & Process Service ("Cavalier") to serve the OIP, along with a Cover Letter and Service and Distribution List (collectively, the "Service Documents") upon Chimene Van Gundy ("Respondent").

3. On December 3, 2024, DOE reported several unsuccessful attempts to obtain service on Respondent. DOE's reported (a) that Cavalier had made multiple attempts at several locations without serving or even locating Respondent; (b) that counsel for DOE had emailed four

different email addresses known to have been used by Respondent, again without confirmation that Respondent had received the Service Documents; (3) and that counsel for DOE had spoken with three different attorneys who were associated with Respondent, each of whom stated that they did not represent Respondent in connection with this administrative proceeding and did not accept service.

4. On February 25, 2025, counsel for DOE contacted an attorney who currently represents Respondent in another matter, asking if Respondent would authorize him to accept service in this matter. On February 27, 2025, the attorney informed counsel for DOE that he “will not be able to receive service on behalf of [his] client.”

5. DOE will continue efforts to serve Respondent and will continue to report its progress to the Commission.
