**DECLARATION OF SANDHYA C. HARRIS**  
**TO ASSIST SECRETARY WITH RECORD OF SERVICE**

SANDHYA C. HARRIS, pursuant to 28 U.S.C. § 1746, declares:

1. I am a Senior Counsel with the Division of Enforcement (“Division”) of the Securities and Exchange Commission, and co-counsel for the Division in the captioned administrative proceeding. I am submitting this Declaration to assist the Secretary in maintaining a record of service on the respondent in the captioned proceeding pursuant to Rule 141(a)(3).
2. Rule 141(a)(2)(ii) provides that service on a corporation or entity may be obtained by confirmation of delivery on an officer, managing or general agent, or any other agent authorized by appointment or law to receive such notice, by any method specified in paragraph (a)(2)(i) of this section.
3. As demonstrated by the Nevada Secretary of State SilverFlume Portal Business Information Page, Respondent has appointed VCorp Services as its registered agent.

4. Pursuant to Nev. Rev. Stat. 77.390, VCorp Agent Services, Inc. (“VCorp”) is authorized to accept service of any process, notice or demand permitted by law (“Notice”) on behalf of Respondent.

5. On October 25, 2024, VCorp purported to reject service.

6. On April 23, 2025 the Division emailed VCorp requesting information about their current status as Respondent’s appointed registered agent. *See* Exhibit 1. Vcorp responded shortly thereafter with confirmation that VCorp is in fact the registered agent for Respondent. *Id.*

7. The Division sent a second copy of the OIP service package to VCorp via Priority Mail Express, Tracking No. EI395829147US, to the address referenced in VCorp’s April 23 response to the Division. I input the tracking number into the U.S. Postal Service’s (“USPS’s”) package tracking system on its Internet website located at [www.usps.com](http://www.usps.com), and printed out the tracking confirmation in order to obtain confirmation of the delivery or attempted delivery of the OIP on the respondent. The UPS tracking system confirms that it was delivered on May 1, 2025. *See* Exhibit 2.

I declare under penalty of perjury that the foregoing is true and correct.
