DECLARATION OF SANDHYA C. HARRIS TO ASSIST SECRETARY WITH RECORD OF SERVICE

SANDHYA C. HARRIS, pursuant to 28 U.S.C. § 1746, declares:

1. I am a Senior Counsel with the Division of Enforcement ("Division") of the Securities and Exchange Commission, and co-counsel for the Division in the captioned administrative proceeding. I am submitting this Declaration to assist the Secretary in maintaining a record of service on the respondent in the captioned proceeding pursuant to Rule 141(a)(3).

2. The Office of the Secretary provided me with the U.S. Certified Mail tracking number for the copy of the Order Instituting Proceedings ("OIP") mailed by the Secretary to the respondent in this proceeding. I input the tracking number into the U.S. Postal Service's ("USPS's") package tracking system on its Internet website located at <u>www.usps.com</u>, and printed out the tracking confirmation in order to obtain confirmation of the delivery or attempted delivery of the OIP on the respondent. A true copy of the tracking confirmation for the respondent is attached as Exhibit 1, hereto. Rule 141(a)(2)(ii) provides that service on a

corporation or entity may be obtained by confirmation of attempted delivery on the most recent address shown on the entity's most recent filing with the Commission.

3. The Secretary mailed the OIP to respondent INTERNATIONAL FAST FOOD CORPORATION, CIK 885549 ("INTERNATIONAL FAST FOOD"), via Certified Mail, Tracking No. 7013 2630 0002 2656 0786, to the address shown on its most recent EDGAR filing at 1000 Lincoln Road, Suite 200 Miami Beach, Florida 33139. This address is taken from INTERNATIONAL FAST FOOD's last filing with the Commission, which was a Form 8-K filed with the Commission on January 2, 2002. The USPS tracking system confirms that the package has been "moving through the network" since October 19, 2024. *See* Exhibit 1.

4. In order to perfect service, I again mailed the OIP to Respondent via Priority Mail Express Tracking No. EJ127655486US, to the address referenced above. The USPS tracking system confirms that delivery was attempted on November 21, 2024 however the business was closed. Although the USPS system contained a notation that the post office would redeliver the package on the next business day, a second attempt was never made and the package remains stuck in transit. *See* Exhibit 2.

 On December 5, 2024, I again mailed the OIP to Respondent via Priority Mail Express, Tracking No. EJ127656036US, to the address referenced above. The USPS tracking system confirms that the package was delivered on December 6, 2024.
