DECLARATION OF SANDHYA C. HARRIS
TO ASSIST SECRETARY WITH RECORD OF SERVICE

SANDHYA C. HARRIS, pursuant to 28 U.S.C. § 1746, declares:

1. I am a Senior Counsel with the Division of Enforcement (“Division”) of the Securities and Exchange Commission, and co-counsel for the Division in the captioned administrative proceeding. I am submitting this Declaration to assist the Secretary in maintaining a record of service on the respondent in the captioned proceeding pursuant to Rule 141(a)(3).
2. The Office of the Secretary provided me with the U.S. Certified Mail tracking number for the copy of the Order Instituting Proceedings (“OIP”) mailed by the Secretary to the respondent in this proceeding. I input the tracking number into the U.S. Postal Service’s (“USPS’s”) package tracking system on its Internet website located at www.usps.com, and printed out the tracking confirmation in order to obtain confirmation of the delivery or attempted delivery of the OIP on the respondent. A true copy of the tracking confirmation for the respondent is attached as Exhibit 1, hereto. Rule 141(a)(2)(ii) provides that service on a

corporation or entity may be obtained by confirmation of attempted delivery on the most recent address shown on the entity's most recent filing with the Commission.

3. Although the address shown in TIHE's last filing with the Commission, a Form 12b-25 filed on November 14, 2023, was in Indonesia, TIHE is a Florida corporation. A search of the website of the Florida Secretary of State revealed that name and address of TIHE's registered agent are Registered Agents Inc. 7901 4th Street N SUITE 300 St. Petersburg, FL 3702. A true copy of a printout of the first page of TIHE's corporate status page from that website is attached hereto as Exhibit 1.

4. Therefore, the Division provided this address to the Office of the Secretary and requested that the Secretary attempt service on TIHE's Florida registered agent via Certified Mail. The Secretary mailed the OIP to TIHE's registered agent at the address referenced above via Express Mail, Tracking No. 70132630000226559131. My search of the USPS tracking system, at www.usps.com, confirmed that it was delivered on October 21, 2024. A true copy of the tracking confirmation is attached hereto as Exhibit 2.

I declare under penalty of perjury that the foregoing is true and correct.
