**DECLARATION OF SANDHYA C. HARRIS**  
**TO ASSIST SECRETARY WITH RECORD OF SERVICE**

SANDHYA C. HARRIS, pursuant to 28 U.S.C. § 1746, declares:

1. I am a Senior Counsel with the Division of Enforcement (“Division”) of the Securities and Exchange Commission, and co-counsel for the Division in the captioned administrative proceeding. I am submitting this Declaration to assist the Secretary in maintaining a record of service on the respondent in the captioned proceeding pursuant to Rule 141(a)(3).
2. The Office of the Secretary provided me with the U.S. Certified Mail tracking number for the copy of the Order Instituting Proceedings (“OIP”) mailed by the Secretary to the respondent in this proceeding. I input the tracking number into the U.S. Postal Service’s (“USPS’s”) package tracking system on its Internet website located at [www.usps.com](http://www.usps.com), and printed out the tracking confirmation in order to obtain confirmation of the delivery or attempted delivery of the OIP on the respondent. A true copy of the tracking confirmation for the respondent is attached as Exhibit 1, hereto. Rule 141(a)(2)(ii) provides that service on a

corporation or entity may be obtained by confirmation of attempted delivery on the most recent address shown on the entity's most recent filing with the Commission.

3. Although the address shown in OS Support's last filing with the Commission, a Form 10-Q filed on March 31, 2023, was in India, OS Support is a Nevada corporation. A search of the website of the Nevada Secretary of State revealed that the name and address of OS Support's registered agent are STATE AGENT AND TRANSFER SYNDICATE, INC. 112 North Curry Street, Carson City, NV, 89703. A true copy of a printout of the first page of OS Support's corporate status page from that website is attached hereto as Exhibit 1.

4. Therefore, the Division provided this address to the Office of the Secretary and requested that the Secretary attempt service on OS Support's Florida registered agent via Certified Mail. The Secretary mailed the OIP to OS Support's registered agent at the address referenced above via Express Mail, Tracking No. 7013 2630 0002 2655 9186. The USPS tracking system confirms that delivery was attempted on October 22, 2024, but the package was refused. *See* Exhibit 2 at page 1.

I declare under penalty of perjury that the foregoing is true and correct.
