DECLARATION OF SANDHYA C. HARRIS
TO ASSIST SECRETARY WITH RECORD OF SERVICE

SANDHYA C. HARRIS, pursuant to 28 U.S.C. § 1746, declares:

1. I am a Senior Counsel with the Division of Enforcement (“Division”) of the Securities and Exchange Commission, and co-counsel for the Division in the captioned administrative proceeding. I am submitting this Declaration to assist the Secretary in maintaining a record of service on the respondent in the captioned proceeding pursuant to Rule 141(a)(3).
2. The Office of the Secretary provided me with the U.S. Certified Mail tracking number for the copy of the Order Instituting Proceedings (“OIP”) mailed by the Secretary to the respondent in this proceeding. I input the tracking number into the U.S. Postal Service’s (“USPS’s”) package tracking system on its Internet website located at www.usps.com, and printed out the tracking confirmation in order to obtain confirmation of the delivery or attempted delivery of the OIP on the respondent. A true copy of the tracking confirmation for the respondent is attached as Exhibit 1, hereto. Rule 141(a)(2)(ii) provides that service on a

corporation or entity may be obtained by confirmation of attempted delivery on the most recent address shown on the entity's most recent filing with the Commission.

The Secretary mailed the OIP to respondent Striker Oil & Gas, Inc., CIK 354507 ("SOIS"), via Certified Mail, Tracking No. 7013 2630 0002 2655 9322, to the address shown on its most recent EDGAR filing at 1125 17th Street, Suite 2300 Denver, CO 80202. This address is taken from SOIS's last filing with the Commission, which was a Form 8-K filed with the Commission on July 10, 2009. The USPS tracking system confirms that delivery was attempted on October 26, 2024 but the forward had expired. *See* Exhibit 1 at page 1.

I declare under penalty of perjury that the foregoing is true and correct.

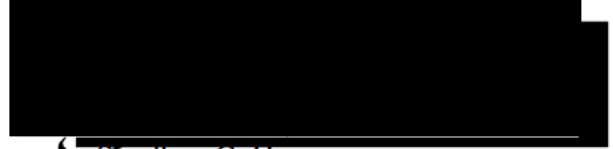
