Dear Security Exchange Commission (SEC)

I am in receipt of your letter dated December 18, 2024 requesting me to access your system electronically and respond to those questions electronically.

I requested the delay initially to inquire and find out the possibility of being allowed to utilize any electronic ability to comply with your request at the Rochester Medical Center where I am located. I have utilized all avenues and have exhausted all options to be allowed to reply electronically to your requests.

At this time I am informing you per paragraph 3 of your letter that I have NO ABILITY AND NO REASONABLE OPPORTUNITY to be able to electronically reply to your requests. I am also advising you per paragraph 3 that my expected ability to electronically respond to your request will not be until I am released from Rochester Medical Center. I have requested a print out of that expected earliest date. The date I will be able to reasonably respond to your request will be 10/18/2028. I have enclosed the Rochester Medical Center printed documentation for proof of earliest release date.

With all the above referenced information and documents provided I would estimate the earliest I would be able to REASONABLY RESPOND to your request will be November 2, 2208.

I respectfully request under my constitutional rights to delay your requests until I can reasonably respond to your inquiries and/or questions which would be as noted above November 2, 2028.
