**UNOPPOSED MOTION TO AMEND

Alpine Securities hereby withdraws its motion filed June 9, 2025 to stay the expedited FINRA proceeding and requests that the Order Scheduling Briefs entered on May 15, 2025 be amended and that the Commission enter an order allowing the filing of overlength briefs and states:

On June 11, 2025, FINRA Department of Enforcement withdrew its petition for hearing in the expedited proceeding No. PCDO230001 and, on June 13, 2023, FINRA's Office of Hearing Officers dismissed the expedited proceeding. As such, Alpine hereby withdraws its motion filed June 9, 2025 to stay the proceeding.

Alpine has conferred with FINRA regarding this appeal and the parties propose that the briefing schedule entered on May 15, 2025 be amended as follows: Alpine will file its brief in support of the application for review by July 22, 2025, FINRA will file its brief in opposition by

September 15, 2025, and Alpine will file its reply by October 6, 2025. Given the complexity of this matter, the parties also request that they be permitted to file overlength briefs up to 18,000 words.
