## MANGAN'S REQUEST FOR A STATUS UPDATE

Mr. John F. Mangan, Jr. respectfully submits this request for a status update on the Commission's consideration of his pending Application for Review. Mr. Mangan has been subject to a meritless Letter of Acceptance, Waiver and Consent ("AWC") for twenty years. In this action, Mr. Mangan seeks review of FINRA's refusal to meaningfully consider his October 17, 2024 petition to vacate this AWC.

Mr. Mangan prevailed in the SEC's case against him, when that matter was dismissed by the Federal District Court for Western District of North Carolina in 2008.<sup>2</sup> FINRA's action against him was based on substantially the same facts and arguments and he has been seeking relief from FINRA ever since. Between 2008 and 2024, Mr. Mangan repeatedly met with Senior FINRA personnel to discuss the AWC and the permanent bar it imposed, and FINRA refused to

act.<sup>3</sup> Mr. Mangan submitted his Petition to the FINRA Board of Governors to Vacate the AWC on October 17, 2024.<sup>4</sup> FINRA again refused to act.<sup>5</sup>

Left with no alternatives, Mr. Mangan filed his Application for Review in this matter on May 23, 2025. Shortly thereafter, FINRA again sought to prevent Mr. Mangan from receiving substantive review of his case, filing a Motion to Dismiss and Stay Briefing on June 9, 2025. The Motion to Dismiss is now fully briefed and is ready for a decision and briefing schedule.

Mr. Mangan therefore respectfully requests a status update on Mr. Mangan's pending Application for Review and FINRA's pending motion.
