**DECLARATION OF GINA JOYCE  
TO ASSIST SECRETARY WITH RECORD OF SERVICE**

GINA JOYCE, pursuant to 28 U.S.C. § 1746, declares:

1. I am Staff Counsel with the Division of Enforcement (“Division”) of the Securities and Exchange Commission, and co-counsel for the Division in the above-captioned administrative proceeding. I am submitting this Declaration to assist the Secretary in maintaining a record of service of the Order Instituting Proceedings (“OIP”) on the respondent, Manuka, Inc. (“MNKA”), in the captioned proceeding pursuant to Rule of Practice 141(a)(3).

2. The address shown in MNKA’s last filing with the Commission, a 10-Q filed on November 21, 2023, is in the country of Israel. *See Exhibit 1* (a true copy of the face page of the 10-Q filed on November 21, 2023). Israel is a signatory to the Hague Convention on the Service Abroad of Judicial and Extrajudicial Documents (“Hague Convention”), 20 U.S.T. 361, T.I.A.S. 6638, 658 U.N.T.A. 163 (1964). “Israel has not objected to Article 10(a). *Israel – Declaration/Reservation/Notification*, Hague Conference on Private International Law (last visited July 14, 2025),

<https://www.hcch.net/en/notifications/?csid=405&disp=resdn>.” *Heagens v. Ganon*,

2025 WL 1937613, at \*3 (D. Nev. July 15, 2025). However, the war that began in October 2023 and continues to this day has been cited as “affecting the efficacy of international mail” delivery in Israel. *Id.*

3. Although its last address is in Israel, MNKA is a Delaware corporation. A search of the website of the Delaware Secretary of State revealed that name and address of MNKA’s registered agent are National Registered Agents, Inc., 1209 Orange Street, Wilmington, DE 19801. A true copy of a printout of the first page of MNKA’s corporate status page from that website is attached hereto as Exhibit 2.

4. The Division provided the registered agent’s address to the Office of the Secretary and requested that the Secretary attempt service on MNKA’s Delaware registered agent via U.S. Certified Mail. The Secretary mailed the OIP to MNKA’s registered agent at the address referenced above via U.S. Certified Mail, Tracking No. 7017 1450 0002 3709 3797. My search of the USPS tracking system, at [www.usps.com](http://www.usps.com), confirmed that the OIP package was delivered to Manuka’s Registered Agent on September 15, 2025. A true copy of the tracking confirmation is attached hereto as Exhibit 3.
