**Respondents' Motion for Extension of
Time to File Reply in Support of Motion to
Amend and Stay Ordered Undertakings**

Pursuant to Rule of Practice 161(a), 17 C.F.R. § 201.161(a), Respondents Perella Weinberg Partners LP (including as successor to Tudor, Pickering, Holt & Co. Securities LLC) and Perella Weinberg Partners Capital Management LP, by and through the undersigned counsel, respectfully request a one-week extension of time—from the current deadline of Tuesday, April 15, 2025, to the following Tuesday, April 22—to file a reply in support of their motion to amend and stay the ordered undertakings (the “Motion”) in the above-captioned administrative proceeding relating to the Commission’s industrywide off-channel communications sweep. The Division of Enforcement (the “Division”) consents to this request for an extension.

Respondents’ Motion was filed and served on March 11, 2025. When the Division had not responded to the Motion, the Commission ordered the Division to file any opposition by today, April 10. The Division served its opposition on Respondents’ counsel this afternoon, and the deadline for Respondents’ reply brief is April 15. The current deadline is challenging due to counsel’s prearranged international travel and the Passover holiday.

Accordingly, Respondents respectfully request that the Commission grant this motion for an extension of time and enter an Order extending the deadline for Respondents' reply brief in support of the Motion to April 22, 2025.
